ORDER ACCEPTING VOLUNTARY SURRENDER OF REAL ESTATE LICENSE

On February 08, 2022, an Accusation was filed in this matter against Respondent AMERICAN DREAM CORPORATION ("Respondent").

On September 11, 2023, Respondent petitioned the Commissioner to voluntarily surrender its real estate broker (corporation) license pursuant to Section 10100.2 of the Business and Professions Code.

CORPORATION 's petition for voluntary surrender of its real estate broker (corporation) license is accepted as of the effective date of this Order as set forth below, based upon the understanding and agreement expressed in Respondent's Declaration dated September 11, 2023, (attached as Exhibit "A" hereto). DECLARATION

My name is Mamady Binta Cisse. I am currently licensed as a real estate broker (DRE license ID 01816666) and I was the designated officer of record for AMERICAN DREAM CORPORATION (DRE license ID 01411740) until its license expiration, and am authorized to act on its behalf. AMERICAN DREAM CORPORATION was licensed as a real estate broker (corporation) until its license expired on December 11, 2021; it currently has license rights with respect to said license. AMERICAN DREAM CORPORATION is representing itself in this matter.

In lieu of proceeding in this matter in accordance with the provisions of the Administrative Procedure Act (Sections 11400 et seq., of the Government Code), AMERICAN DREAM CORPORATION wishes to voluntarily surrender its real estate license(s) issued by the Department of Real Estate ("Department"), pursuant to Business and Professions Code Section 10100.2.

 I understand, on behalf of AMERICAN DREAM CORPORATION, that by so voluntarily surrendering its license(s), it may be relicensed as a broker, or issued a new mortgage loan originator endorsement, only by petitioning for reinstatement pursuant to Section 11522 of the Government Code. I also understand, on behalf of AMERICAN DREAM CORPORATION, that by so voluntarily surrendering its license(s), I, on behalf of AMERICAN DREAM CORPORATION, agree to the following:

- The filing of this Declaration shall be deemed as AMERICAN DREAM CORPORATION's petition for voluntary surrender.
- 2. It shall also be deemed to be an understanding and agreement by me on behalf of AMERICAN DREAM CORPORATION that it waives all rights it has to require the Commissioner to prove the allegations contained in the Accusation filed in this matter at a hearing held in accordance with the provisions of the Administrative Procedure Act (Government Code Sections 11400 et seq.), and that it also waives other rights afforded to it in connection with the hearing such as the right to discovery, the right to present evidence in defense of the allegations in the Accusation and the right to cross-examine witnesses.
- 3. I further agree, on behalf of AMERICAN DREAM CORPORATION, that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence obtained by the Department in this matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed in the Department Case No. H-05276 SD, may be considered by the Department to be true and correct for the purpose of deciding whether to grant relicensure or reinstatement pursuant to Government Code Section 11522.
- 4. Upon its application for relicensure or reinstatement, I further agree, on behalf of AMERICAN DREAM CORPORATION, that AMERICAN DREAM CORPORATION will pay, pursuant to Business and Professions Code Section 10106, its portion of the Commissioner's reasonable cost for the investigation and enforcement which led to this action. I,

on behalf of AMERICAN DREAM CORPORATION, am aware that its portion of the Commissioner's reasonable cost for the investigation and enforcement which led to this action is fifty percent (50%), or one-half, of the total investigation and enforcement costs incurred by the Department. I am aware that the Department's reasonable investigation and enforcement costs incurred in the instant case total \$4,259.20 (comprised of \$3,246.40 in investigation costs and \$1,012.80 in enforcement costs). I am aware that if AMERICAN DREAM CORPORATION petitions for reinstatement of its license(s) in the future, that payment of its portion of the Department's reasonable investigation and enforcement costs incurred in the instant case, which is \$2,129.60, will be a condition of reinstatement.

5. I, on behalf of AMERICAN DREAM CORPORATION, freely and voluntarily surrender all my licenses and license rights under the Real Estate Law.
