ORDER SUSPENDING RESTRICTED REAL ESTATE LICENSE

(Professional Responsibility Examination)

TO: CRISELDA G. CENTENO (Respondent):

On October 24, 2011, a restricted real estate salesperson license was issued by the Department of Real Estate (Department) to Respondent on the terms, conditions and restrictions set forth in the Real Estate Commissioner's (Commissioner) Order effective October 24, 2011, in Case No. H-5442 SAC. This Order granted the right to the issuance of a restricted real estate salesperson license subject to the provisions of Section 10156.7 of the Business and Professions Code (Code) of the State of California, and to enumerated additional terms, conditions and restrictions imposed under authority of Section 10156.6 of said Code. Among those terms, conditions and restrictions, the Decision required Respondent, within six months after October

1 24, 2011, the effective date of the Order, to take and pass the Professional Responsibility
2 Examination administered by the Department, including payment of the appropriate examination
3 fee, and provided that if Respondent failed to satisfy this condition, the Commissioner may order
4 suspension of the restricted real estate salesperson license until Respondent passes the
5 examination.

6 To date, Respondent has failed to submit proof satisfactory to the Commissioner
7 of successfully passing the above-ordered examination. The Commissioner has determined that
8 Respondent has failed to satisfy this condition, and as such, that Respondent's license may be
9 suspended until Respondent satisfies this condition.

10 NOW, THEREFORE, IT IS ORDERED pursuant to the Order of October 24,
11 2011, that Respondent's restricted real estate salesperson license and the exercise of any
12 privileges thereunder be and hereby is suspended until such time as Respondent provides proof
13 satisfactory to the Commissioner of compliance with the condition referred to above, or pending
14 final determination made after hearing (see "Hearing Rights" set forth below).

15 IT IS FURTHER ORDERED that all license certificates and identification cards
16 issued by the Department of Real Estate which are in the possession of Respondent be
17 immediately surrendered by personal delivery or by mailing in the enclosed self-addressed,
18 stamped envelope:


22 HEARING RIGHTS: You have the right to a hearing to contest the
23 Commissioner's determination that you are in compliance with this condition. If you desire a
24 hearing, you must submit a written request. The request may be in any form, as long as it is in
25 writing and indicates that you want a hearing. Unless a written request for a hearing, signed by
26 or on behalf of you, is delivered or mailed to the Department, Legal Section, at 2201 Broadway,
27 P. O. Box 187007, Sacramento, California 95818-7007, within twenty (20) days after the date

1 that this Order was mailed to or served on you, the Department will not be obligated or required
2 to provide you with a hearing.

3 This Order shall be effective immediately.
