. 4	5. Based on the findings of fact contained in paragraphs 1 through 3,	
5	D. BATTISTA, and N. BATTISTA, among other things, solicited and/or performed services for	
6	landlords, borrowers, including but not limited collecting rents and depositing the same into trust	
7	accounts, offering places to rent on behalf of landlords, for or in expectation of a compensation	
8	and claimed, demanded, charged, received, collected or contracted for an advance fee for such	
9	services. Thus, D. BATTISTA violated Section 10137 and or Section 10138 of the Code and	
.10	N. BATTISTA violated Sections 10130 and 10131(b) of the Code.	
11	DESIST AND REFRAIN ORDER	
12	Now, therefore NIKKI BATTISTA IS HEREBY ORDERED to immediately	
13	desist and refrain from:	
14	(1) Performing any and all acts within the State of California for which a real estate	
15	salesperson or broker license is required, unless and until he or she obtains a real	
16	estate salesperson or broker license;	
17	Now, therefore DARA LYNN BATTISTA, her employees, agents, official	
18	successors and assigns, IS HEREBY ORDERED to immediately desist and refrain from:	
19	(1) Employing and/or compensating unlicensed persons for performing acts which	
20	require a real estate license until those persons are properly licensed as real estate	
21	salespersons or real estate brokers.

2	Business and Professions Code Section 10139 provides that "Any person acting
	as a real estate broker or real estate salesperson without a license or who advertises using words
4	indicating that he or she is a real estate broker without being so licensed shall be guilty of a
5	public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by
6	imprisonment in the county jail for a term not to exceed six months, or by both fine and
7	imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars
8	(\$60,000)''
