19	including engaging in the business of, acting in the capacity of, advertising, or assuming to act	
20	as a real estate broker in the State of California within the meaning of Section 10131(d) of the	
21	California Business and Professions Code (the Code). Based upon the findings of that	
22	investigation, as set forth below, the Commissioner has determined and is of the opinion that:	
23	W2U and HUSSAIN have violated Section 10137 of the Code by employing and/or	
24	compensating one or more unlicensed persons to act in the capacity of a real estate broker or	
25	salesperson; and WILLETTE, has violated Section 10130 of the Code by engaging in the	
26	business of or acting as a real estate salesperson or broker, within the meaning of Sections	
27	10085.5 (Charging an Advance Fee), 10130 (Act as a Real Estate Broker or Salesperson Without

1 a License) and 10131(d) (Soliciting Borrowers For Services in Connection With Loans Secured 2 By Real Property) of the Code without first having obtained a real estate license from the 3 California Department of Real Estate (Department). Whenever acts referred to below are 4 attributed to W2U, those acts are alleged to have been done by W2U, acting by itself, or by 5 and/or through one or more agents, associates, and/or co-conspirators, and using other names or 6 fictitious names unknown at this time (the related entities). 7 **FINDINGS OF FACT** 8 1. Since February 23, 2010 W2U has been licensed by the Department 9 corporate real estate broker. 10 Since August 3, 2009, HUSSAIN has been licensed and/or has license 2. 11 rights as a real estate broker. 12 3. At no time mentioned herein was WILLETTE licensed by the Department 13 as a real estate broker or real estate salesperson, as appropriate. 14 4. At all times mentioned herein between on or about March of 2009, and 15 continuing up to at least September of 2010, W2U engaged in the business of, acted in the 16 capacity of, or assumed to act as a real estate broker within the State of California within the 17 meaning of Section 10131(d) of the Code, including solicitation of borrowers for or negotiation 18 of loans or performance of services for borrowers or lenders or note owners in connection with 19 loans secured directly or collaterally by liens on real property, including but not limited to direct 20 solicitation as described above of individual mortgage borrowers Safaa K. and Manna T. of 21 Sacramento, California and Mitchell S. of Cameron Park, California. 22 5. [`] From approximately August 3, 2009 through September 2010, HUSSAIN 23 employed and/or compensated WILLETTE for performing acts which require a real estate 24 license pursuant to Section 10131(d) of the Code (Soliciting or Negotiating Loans Secured By 25 Real Property). 26 /// 27 111 ORDER TO DESIST AND REFRAIN - 2 -WEFIT2U, INC., ET AL.

6. From February 23, 2010 through September 2010, W2U employed and/or
 compensated WILLETTE for performing acts which require a real estate license pursuant to
 Section 10131(d) of the Code.

7. During the period of time set out above, W2U, HUSSAIN and
WILLETTE solicited borrowers and negotiated to do one or more of the following acts for
another or others, for or in expectation of compensation: negotiate one or more loans for, or
perform services for, borrowers and/or lenders in connection with loans secured directly or
collaterally by one or more liens on real property; and charge, demand or collect an advance fee
for any of the services offered.

CONCLUSIONS OF LAW

Based on the Findings of Fact contained in paragraphs 1 through 5,
 WILLETTE, among other things, solicited and/or performed services for borrowers, including
 but not limited to Safaa K., Manna T. and Mitchell S., in connection with loans secured directly
 or collaterally by liens on real property or on a business opportunity, for or in expectation of
 compensation and claimed, demanded, charged, received, collected or contracted for an
 advanced fee for such services. Thus, WILLETTE violated Sections 10130, 10131(d) and
 10085.5 of the Code.

Based on the Findings of Fact contained in Paragraphs 1 through 5, above,
 LISA WILLETTE has performed and/or participated in soliciting and/or negotiating loans
 secured by real property which require a real estate license under Section 10131(d) of the Code
 during a period of time when LISA WILLETTE was not licensed by the Department in any
 capacity, in violation of Section 10130 of the Code.

3. Based on the Findings of Fact contained in paragraphs 1 through 5, W2U
and HUSSAIN, among other things, solicited and/or performed services for borrowers, including
but not limited to Safaa K., Manna T. and Mitchell S., in connection with loans secured directly
or collaterally by liens on real property or on a business opportunity, for or in expectation of

12	Now, therefore, WEFIT2U, INC. and CHRISTOPHER VINCENT HUSSAIN,		
13	ARE HEREBY ORDERED to immediately Desist and Refrain from:		
14	1. Employing and/or compensating any person for performing any acts		
15	which require a real estate license within the State of California unless and until that person has		
16	obtained from the Department a real estate salesperson or real estate broker license.
