(AFGI) dba Culp Mortgage, PETER SCALISE (SCALISE), and EDWIN B. 19 HETHERTON (HETHERTON). Based on that investigation, the Commissioner has determined 20 that AFGI, SCALISE, and HETHERTON have engaged in, are engaging in, or are attempting to 21 engage in, acts or practices constituting violations of the California Business and Professions 22 Code (Code) and/or Title 10, Chapter 6, California Code of Regulations (Regulations) including 23 acting in the capacity of, advertising, or assuming to act as real estate brokers in the State of 24 California, within the meaning of Section 10131(d) (mortgage loan activities) of the Code. 25

Furthermore, based on the investigation, the Commissioner hereby issues the following Findings

of Fact and Desist and Refrain Order under the authority of Section 10086 of the Code.

FINDINGS OF FACT

- 1. At no time herein mentioned has AFGI been licensed by the Department in any capacity.
- 2. At no time herein mentioned has SCALISE been licensed by the Department in any capacity.
- 3. At no time herein mentioned has HETHERTON been licensed by the Department in any capacity.
- 4.- During the period of time set out below, AFGI, SCALISE, and HETHERTON negotiated to do one or more of the following acts for another or others, for or in expectation of compensation: solicited lenders and borrowers for loans secured directly or collaterally by liens on real property, and arranged, negotiated, processed, and consummated such loans.
- 5. On or about October 12, 2007, AFGI, SCALISE, and HETHERTON acting through dba Culp Mortgage, negotiated a loan in the amount of \$396,500.00 for Joseph and Kristin T. secured by real property located in Roseville, CA, wherein AFGI, SCALISE and HETHERTON fraudulently misrepresented themselves as real estate licensees.

CONCLUSIONS OF LAW

Based on the Findings of Fact contained in Paragraphs 1 through 5, above, AFGI, SCALISE, and HETHERTON have performed and/or participated in mortgage loan activities which require a real estate license under Sections 10130 and 10131(d) of the Code during a period of time when AFGI, SCALISE, and HETHERTON were not licensed by the Department in any capacity.

DESIST AND REFRAIN ORDER

Based upon the Findings of Fact and Conclusions of Law stated herein, you AZZURE FINANCIAL GROUP, INC. dba Culp Mortgage, PETER SCALISE, and EDWIN B. HETHERTON, ARE HEREBY ORDERED to immediately Desist and Refrain from performing any acts within the State of California for which a real estate broker license is required, and in particular, that you immediately Desist and Refrain from providing or participating in mortgage

1	loan activities for others and for compensation unless and until you, individually, obtain an
2	appropriate license issued by the Department.
