At all times mentioned herein between on or about November 24, 2009, and 2 continuing up to at least November of 2010, VIDES engaged in the business of, acted in the 3 capacity of, or assumed to act as a real estate broker within the State of California within the 4 meaning of Section 10131(d) of the Code, including solicitation of borrowers for or negotiation 5 of loans or performance of services for borrowers or lenders or note owners in connection with 6 loans secured directly or collaterally by liens on real property, including but not limited to direct 7 solicitation as described above of individual mortgage borrower Erlinda A. of San Francisco, 8 California.

3. During the period of time set out above, VIDES solicited borrowers and
negotiated to do one or more of the following acts for another or others, for or in expectation of
compensation: negotiate one or more loans for, or perform services for, borrowers and/or
lenders in connection with loans secured directly or collaterally by one or more liens on real
property; and charge, demand or collect an advance fee for any of the services offered.

CONCLUSIONS OF LAW

Based on the findings of fact contained in paragraphs 1 through 3, VIDES,
 among other things, solicited and/or performed services for borrowers, including but not limited
 to Erlinda A., in connection with loans secured directly or collaterally by liens on real property
 or on a business opportunity, for or in expectation of a compensation and claimed, demanded,
 charged, received, collected or contracted for an advanced fee for such services. Thus, VIDES
 violated Section 10085.5 of the Code.
