## FINDINGS OF FACT

- 1. At no time after December 30, 2009 was SHIPLEY, licensed by the Department as a real estate broker or real estate salesperson, as appropriate.
- 2. At all times mentioned herein between on or about January 12, 2010 and continuing up to at least April 29, 2011, SHIPLEY engaged in the business of, acted in the capacity of, or assumed to act as a real estate broker within the State of California within the meaning of Section 10131(b) of the Code, including leasing, renting, or offering places to rent, negotiating the sale or purchase of leases of real property or collecting rents on real property for compensation or in expectation of compensation, including but not limited to real property commonly known as: 1721 Stone Canyon Drive, Roseville, California and 3850 Robertson Avenue, Sacramento, California.

## **CONCLUSIONS OF LAW**

3. Based on the findings of fact contained in paragraphs 1 and 2, SHIPLEY, among other things, solicited and/or performed services for landlords, borrowers, including but not limited collecting rents and depositing the same into trust accounts, offering places to rent on behalf of landlords, for or in expectation of a compensation and claimed, demanded, charged, received, collected or contracted for an advanced fee for such services. Thus, SHIPLEY violated Sections 10130 and 10131(b) of the Code.

Business and Professions Code Section 10139 provides that "Any person acting as a real estate broker or real estate salesperson without a license or who advertises using words indicating that he or she is a real estate broker without being so licensed shall be guilty of a public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by imprisonment in the county jail for a term not to exceed six months, or by both fine and imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars (\$60,000)...."
