16 The Commissioner (Commissioner) of the California Department of Real Estate  
17 (Department) caused an investigation to be made of the activities of SEISIN ENTERPRISES,  
18 INC. (SEISIN) dba Full Service Property Management (FSPM), KIMBERLY A. HENDERSON  
19 (HENDERSON), and DAVID MIKEL HOWARD (HOWARD). Based on that investigation, the  
20 Commissioner has determined that SEISIN, HENDERSON, and HOWARD have engaged in,  
21 are engaging in, or are attempting to engage in, acts or practices constituting violations of the  
22 California Business and Professions Code (Code) and/or Title 10, Chapter 6, California Code of  
23 Regulations (Regulations) including acting in the capacity of, advertising, or assuming to act as  
24 real estate brokers in the State of California within the meaning of Code Section 10131(b)  
25 (property management services). Furthermore, based on the investigation, the Commissioner  
26 hereby issues the following Findings of Fact and Desist and Refrain Order under the authority of  
27 Code Section 10086.

1 FINDINGS OF FACT

2 1. At no time herein mentioned has SEISIN been licensed by the Department in  
3 any capacity.

4 2. At no time herein mentioned has HENDERSON been licensed by the  
5 Department in any capacity.

6 3. At no time herein mentioned has HOWARD been licensed by the Department  
7 in any capacity.

8 4. During the periods of time set out below, SEISIN dba FSPM, HENDERSON,  
9 and HOWARD negotiated to do one or more of the following acts for another or others, for or in  
10 expectation of compensation: lease or rent or offer to lease or rent; place for rent; solicit listings  
11 of places for rent; solicit for prospective tenants; negotiate the sale, purchase or exchange of  
12 leases on real property, or on a business opportunity; collect rents from real property, or  
13 improvements thereon, or from business opportunities.

14 5. On or about September 24, 2010, SEISIN dba FSPM and HOWARD solicited  
15 Frank Z., offering "a full suite of property management services" including soliciting and placing  
16 prospective tenants into rental properties and providing "high quality property management services".

17 6. On or about October 6, 2010, SEISIN dba FSPM and HENDERSON solicited  
18 property management services through the SEISIN dba FSPM website and a telephone  
19 conversation with Department employee (Heather N.), which included marketing the property,  
20 collecting rents and security deposits, and soliciting, qualifying, and placing prospective tenants in  
21 Heather N's rental property.

22 CONCLUSIONS OF LAW

23 7. Based on the Findings of Fact contained in Paragraphs 1 through 6, SEISIN  
24 dba FSPM, HENDERSON, and HOWARD have performed and/or participated in property  
25 management activities which require a real estate license under Code Sections 10130 and  
26 10131(b) during a period of time when SEISIN dba FSPM, HENDERSON, and HOWARD were  
27 not licensed by the Department in any capacity.

DESIST AND REFRAIN ORDER

Based upon the Findings of Fact and Conclusions of Law stated herein, you SEISIN ENTERPRISES, INC., dba Full Service Property Management, KIMBERLY A. HENDERSON, and DAVID MIKEL HOWARD, ARE HEREBY ORDERED to immediately Desist and Refrain from performing any acts within the State of California for which a real estate broker license is required, and in particular, that you immediately Desist and Refrain from providing or participating in property management services for others and for compensation unless and until you, individually, obtain an appropriate license issued by the Department.

- NOTICE -

Business and Professions Code Section 10139 provides that, "Any person acting as a real estate broker or real estate salesperson without a license or who advertises using words indicating that he or she is a real estate broker without being so licensed shall be guilty of a public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by imprisonment in the county jail for a term not to exceed six months, or by both fine and imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars (\$60,000)."
