I also understand that by so voluntarily surrendering my license(s), I agree to the following: 25 1. The filing of this Declaration shall be deemed as my petition for voluntary surrender. 26 2. It shall also be deemed to be an understanding and agreement by me that I waive all 27

rights I have to require the Commissioner to prove the allegations contained in the Accusation filed in

this matter at a hearing held in accordance with the provisions of the Administrative Procedure Act (Government Code Sections 11400 et seq.), and that I also waive other rights afforded to me in connection with the hearing such as the right to discovery, the right to present evidence in defense of the allegations in the Accusation, and the right to cross-examine witnesses.

- 3. I further agree that upon acceptance by the Commissioner, as evidenced by the appropriate order, all affidavits and all relevant evidence obtained by the Department in this matter prior to the Commissioner's acceptance may be considered by the Department to be true and correct for the purposes of deciding whether to grant re-licensure or reinstatement pursuant to Government Code Section 11522.
- 4. I freely and voluntarily surrender all my licenses and license rights under the Real Estate Law.
