In lieu of proceeding in this matter in accordance with the provisions of the Administrative Procedure Act (Sections 11400 et seq., of the Government Code), Respondents wish to voluntarily surrender their real estate licenses, issued by the Department of Real Estate ("Department"), pursuant to Business and Professions Code Section 10100.2.

Respondents understand that by so voluntarily surrendering their licenses, they may be relicensed as brokers, or as a salesperson, or issued a mortgage loan originator endorsement, only by petitioning for reinstatement pursuant to Section 11522 of the Government Code. Respondents also understand that by so voluntarily surrendering their real estate licenses, they agree to the following:

- The filing of this Declaration shall be deemed as their petition for voluntary surrender.
- 2. It shall also be deemed to be an understanding and agreement by Respondents that they waive all rights they have to require the Commissioner to prove the allegations contained in the Accusation filed in this matter at a hearing held in accordance with the provisions of the Administrative Procedure Act (Government Code Sections 11400 et seq.), and that they also waive other rights afforded to them in connection with the hearing such as the right to discovery, the right to present evidence in defense of the allegations in the Accusation and the right to cross-examine witnesses.

Respondents further agree that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence obtained by the Department in this matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed in the Department Case No. H-05693 SD, may be considered by the
