	violations of the California Business and Professions Code (hereinafter "the Code") and/or title	
20	10, chapter 6, California Code of Regulations (hereinafter "the Regulations"), including the	1
21	business of, acting in the capacity of, and/or advertising or assuming to act as, a real estate	
22	broker in the State of California within the meaning of section 10131(b) (property management	
23	services). Based on the investigation, the Commissioner hereby issues the following Findings	
24	of Fact, Conclusions of Law, and Desist and Refrain Order under the authority of section 10086

## FINDINGS OF FACT

1

2	1. At all times mentioned herein, ARBOUR was licensed by			
3	the Department of Real Estate (hereinafter "Department") as a corporate real estate broker.			
4	2. At all times mentioned herein, Mr. MUNZ was licensed by the			
5	Department as a real estate broker. Mr. MUNZ passed away on or about December 13, 2010.			
6	Before his passing, Mr. MUNZ served as the designated broker-officer for ABROUR and the			
7	broker of record for Ms. Munz.			
8	3. At all times relevant herein Respondent Ms. MUNZ was licensed by the			
9	Department as a real estate salesperson. Mr. MUNZ remains the broker of record for Ms.			
10	MUNZ. At no time relevant herein has Ms. MUNZ applied for and obtained a real estate broker			
11	license.			
12	4. During the period of time set forth below, ARBOUR and Ms. MUNZ, on			
13	behalf of others, for compensation or in expectation of compensation, leased or rented and			
14	offered to lease or rent, and solicited for prospective tenants of real property or improvements			
15	thereon, and collected rents from real property or improvements thereon.			
16	5. Since December 14, 2010, ARBOUR and Ms. MUNZ, in the course of the			
17	property management brokerage activities described above, solicited prospective tenants for,			
18	negotiated rental agreements for, and/or collected rents from real properties owned by another or			
19	others, including, but not limited to the rental proprieties located at:			
20	a. 8065 Dorian Way, Fair Oaks, California 95628;			
21	b. 8869 C La Riviera Dr., Sacramento, California 95826.			
22	c. 6342-44 Sorrell Ct., Citrus Heights, California 95621

## CONCLUSIONS OF LAW

6. Based on the findings of fact contained above in Paragraphs 1 through 5,
ARBOUR has performed and/or participated in property management activities under sections
10130 and 10131(b) of the Code without a currently licensed designated broker-officer that has
been approved as such by the Department.

7. Based on the findings of fact contained above in Paragraphs 1 through 5,
Ms. MUNZ has performed and/or participated in property management activities under sections
10130 and 10131(b) of the Code without proper licensure as a California real estate broker.

## DESIST AND REFRAIN ORDER

10 Based on the Findings of Fact and Conclusions of Law stated herein, ARBOUR 11 REAL ESTATE MANAGEMENT, INC., whether doing business under its own name, or any other names or fictitious names, IS HEREBY ORDERED to immediately desist and refrain from 12 13 performing any acts within the State of California for which a real estate broker license is 14 required, including, but not limited to, soliciting or providing or participating in property 15 management services for others and for compensation, unless and until its acts requiring a real 16 estate broker license are supervised by a currently licensed designated broker-officer that has 17 been approved as such by the Department.

Based on the Findings of Fact and Conclusions of Law stated herein, JUDITH
MAE MUNZ, whether doing business under her own name, or any other names or fictitious
names, IS HEREBY ORDERED to immediately desist and refrain from performing any acts
within the State of California for which a real estate broker license is required, including, but not
limited to, soliciting or providing or participating in property management services for others and
