DECLARATION

My name is HENRY JOSEPH ZELLMAN, III, I am currently licensed as a real estate broker individually and as designated officer-broker for DBX CAPITAL, INC. (herein "DBX") and have license rights with respect to both licenses. DBX is represented by C. Christian Thompson, Attorney at Law. I am representing myself in this matter.

In lieu of proceeding in this matter in accordance with the provisions of the Administrative Procedure Act (Sections 11400 et seq., of the Government Code), I wish to voluntarily surrender the corporate real estate broker license of DBX issued by the Department of Real Estate (herein the "Department") pursuant to Business and Professions Code Section 10100.2.

I understand that by so voluntarily surrendering the license of DBX, DBX may be relicensed as a broker only by petitioning for reinstatement pursuant to Section 11522 of the Government Code.

I also understand that by so voluntarily surrendering said license, DBX and I agree to the following:

- 1. The filing of this Declaration shall be deemed as the petition for DBX for voluntary surrender.
- 2. It shall also be deemed to be an understanding and agreement by me on behalf of DBX, that DBX waives all rights it has to require the Commissioner to prove the allegations contained in the Accusation filed in this matter at a hearing held in accordance with the provisions of the Administrative Procedure Act (Government Code Sections 11400 et seq.), and that DBX also waives other rights afforded in connection with the hearing such as the right to discovery, the right to present evidence in defense of the allegations in the Accusation and the right to cross-examine witnesses.
- 3. I, on behalf of DBX, further agree that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence obtained by the Department in this matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed in the Department Case No. H-5961 SAC, may be considered by the Department to be true and correct for the purpose of deciding whether to grant relicensure or reinstatement pursuant to Government Code Section 11522.
- 4. This voluntary surrender and DBX' decision not to contest the Accusation are made for the purpose of reaching an agreed disposition of this proceeding, and, except as set forth above, shall not be admissible in any other criminal or civil proceedings.


