| 17 | The Real Estate Commissioner of the State of California (Commissioner) has | | |
| 18 | caused an investigation to be made of the activities of WEFIT2U, INC. (W2U) and | | |
| 19 | CHRISTOPHER VINCENT HUSSAIN (HUSSAIN), including engaging in the business of, | | |

connection with loans secured by real property) of the Code without first having obtained a real

estate license from the California Department of Real Estate (Department) and without having

obtained a mortgage loan originator license endorsement (MLO Endorsement) from the Department in violation of Section 10166.02(b) of the Code. Whenever acts referred to below are attributed to W2U, those acts are alleged to have been done by W2U, HUSSAIN, acting by itself, or by and/or through one or more agents, associates, and/or co-conspirators, and using other names or fictitious names unknown at this time (the related entities).

FINDINGS OF FACT

- 1. At no time mentioned herein was W2U licensed by the Department as a real estate broker, having its corporate real estate broker license revoked on or about October 30, 2011.
- 2. At no time mentioned herein was HUSSAIN licensed by the Department as a real estate broker, having his real estate broker license revoked on or about October 30, 2011.
- 3. At no time mentioned herein did W2U hold an MLO Endorsement issued by the Department.
- 4. At no time mentioned herein did HUSSAIN hold an MLO Endorsement issued by the Department.
- 5. On or about March 27, 2013, a Department Special Investigator (SI) placed a shopper call to W2U in order to determine if acts requiring a license were being preformed. The SI represented that she sought a loan modification for her residence. HUSSAIN answered the call, identifying himself as Christopher. During the phone call, HUSSAIN represented that he and W2U could help the SI get a loan. The SI represented that her credit score was 625 and that her bank could not help her with a loan. HUSSAIN represented to the SI that he had programs that went to credit scores of 580, with 3.5% down, and 500 with 10% down. He said that it would take 10 minutes to prequalify the SI. The SI declined to go forward and ended the phone call.
- 6. At all times mentioned herein between, but not limited to, March 27, 2013, and April 4, 2013, W2U and HUSSAIN maintained, updated, serviced, and otherwise operated websites under wefit2u.com/lending, wefit2u.com/contract processing, wefit2u.com/loss

mitigation and wefit2u.com/lending/about_mission. Through these websites, W2U and HUSSAIN represented that they would "Examine specific mortgage needs and tap into our unmatched resources", they would "shop loans", that they would "start the loan application process", that they "know what it takes to close a loan", that they "only process loans for our clients", that they "provide loan status" and that they "work with lenders". One of the websites was directed to financial institutions, soliciting them to hire W2U as a "contract loan processor". Another web site solicited individuals to work for W2U, extolling the benefits of working from home, but never mentioned the need for a real estate license or MLO Endorsement to conduct loan activities.

CONCLUSIONS OF LAW

Based on the Findings of Fact contained in paragraphs 1 through 6, W2U and HUSSAIN, among other things, solicited and/or performed services for borrowers, including but not limited to the Department Special Investigator, in connection with loans secured directly or collaterally by liens on real property or on a business opportunity, for or in expectation of a compensation. Thus, W2U and HUSSAIN violated Sections 10130, 10166.02(b) and 10166.03 of the Code.

DESIST AND REFRAIN ORDER

Now, therefore WEFIT2U, INC. and CHRISTOPHER VINCENT HUSSAIN, their employees, agents, official successors and assigns, ARE HEREBY ORDERED to immediately desist and refrain from:

- (1) Performing any and all acts within the State of California for which a real estate broker license is required, unless and until they obtain a real estate broker license.
- (2) Performing any acts within the State of California for which a mortgage loan originator license endorsement is required. In particular, you are ordered to desist and refrain from taking a residential mortgage loan application or offering or negotiating terms of a residential mortgage loan for compensation, unless and until you obtain a mortgage loan originator license endorsement issued by the Department.

Notice: Business and Professions Code Section 10139 provides that, "Any person acting as a real estate broker or real estate salesperson without a license or who advertises using words indicating that he or she is a real estate broker without being so licensed shall be guilty of a public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by imprisonment in the county jail for a term not to exceed six months, or by both fine and imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars (\$60,000)..."
