14	The Real Estate Commissioner (Commissioner) of the California Bureau of Real

23	FINDINGS OF FACT			
24	1. At no time herein mentioned has MURILLO been licensed by the Bureau in			
25	any capacity.			
26	2. Between about November 2009 and December 2011, MURILLO performed			
27	licensed activities including short sale negotiations with lenders on behalf of sellers, for

properties located on Codington Way in Modesto, CA, and on Massimo Circle in Stockton, CA,
in violation of Sections 10130 and 10137 of the Code.

CONCLUSIONS OF LAW

3. Based on the Findings of Fact contained in Paragraphs 1 and 2, MURILLO has performed and/or participated in property sales activities including short sale negotiations which require a real estate license under Sections 10130 and 10131(a) of the Code during a period of time when MURILLO was not licensed by the Bureau in any capacity.

DESIST AND REFRAIN ORDER

Based upon the Findings of Fact and Conclusions of Law stated herein, DANIEL MURILLO, IS HEREBY ORDERED to immediately Desist and Refrain from performing any acts within the State of California for which a real estate license is required, and in particular, immediately Desist and Refrain from providing or participating in property sales including negotiating short sale negotiations for others for compensation unless an appropriate license is obtained and issued by the Bureau.
