

19	ORDER ACCEPTING VOLUNTARY SURRENDER OF REAL ESTATE LICENSES	
20	On December 4, 2012, in Case No. H-5921 SAC, an Accusation was filed	
21	against JEANETTE DENOGEAN CHAMPAGNE (Respondent CHAMPAGNE) and GINA	
22	MARIE WEST (Respondent WEST). On March 18, 2013, a Default Decision was filed	
23	revoking Respondent CHAMPAGNE's real estate broker license effective April 8, 2013.	
24	On April 8. 2014, in Case No. H-6106 SAC, an Accusation was filed against	
25	CATHERINE RENE KING (Respondent KING), GINA MARIE WEST (Respondent WEST)	
26	and SHASTA PROPERTIES, INC. (Respondent SHASTA).

1	On June 9, 2015, Respondent WEST and Respondent SHASTA petitioned the	
2	Commissioner to voluntarily surrender Respondent WEST's real estate salesperson license and	
3	Respondent SHASTA's real estate corporation license, pursuant to Section 10100.2 of the	
4	Business and Professions Code.	
5	IT IS HEREBY ORDERED that Respondent WEST's and Respondent	
6	SHASTA's petition for voluntary surrender of Respondent WEST's real estate salesperson	
7	license and Respondent SHASTA's real estate corporation license are accepted as of the	
8	effective date of this Order as set forth below, based upon the understanding and agreement	
9	expressed in Respondents' Declaration dated June 9, 2015, (attached as Exhibit "A" hereto).	
10	Respondents' license certificates, pocket cards and any branch office license	
11	certificates shall be sent to the below listed address so that they reach the Bureau on or before	
12	the effective date of this Order:

(Sections 11400 et seq., of the Government Code), I wish to voluntarily surrender my real estate
 salesperson license and the corporate real estate broker license of SPI issued by the Bureau of
 Real Estate (Bureau) pursuant to Business and Professions Code Section 10100.2.

I understand that by so voluntarily surrendering my license and the license of SPI,
I may be relicensed as a salesperson or as a broker, and SPI may be relicensed as a corporate
broker, only by petitioning for reinstatement pursuant to Section 11522 of the Government Code.

7 I also understand that by so voluntarily surrendering said licenses, SPI and I agree
8 to the following:

1. The filing of this Declaration shall be deemed as the petition of SPI and
10
myself for the voluntary surrender of our respective licenses.

11 2. It shall also be deemed to be an understanding and agreement by me on my
12 own behalf and on behalf of SPI, that SPI and I waive all rights we have to require the
13 Commissioner to prove the allegations contained in the Accusations filed in these matters at a
14 hearing held in accordance with the provisions of the Administrative Procedure Act (Government
15 Code Sections 11400 et seq.), and that SPI and I also waive other rights afforded to SPI and me
16 in connection with the hearing such as the right to discovery, the right to present evidence in
17 defense of the allegations in the Accusations and the right to cross-examine witnesses.

3. I, on behalf of SPI and on my own behalf, further agree that upon
acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all
relevant evidence obtained by the Bureau in these matters prior to the Commissioner's
acceptance, and all allegations contained in the Accusations filed in the Bureau Case Nos. H5921 SAC and H-6106 SAC, may be considered by the Bureau to be true and correct for the
purpose of deciding whether to grant relicensure or reinstatement pursuant to Government Code
Section 11522.

4. SPI and my voluntary surrenders and SPI and my decision not to contest
the Accusation Case Nos. H-5921 SAC and H-6106 SAC are made for the purpose of reaching
an agreed upon disposition of these proceedings, and, except as set forth above, shall not be
admissible in any other criminal or civil proceedings.

1 5. SPI and I freely and voluntarily surrender SPI and my licenses and license 2 rights under the Real Estate Law.

6. I understand that if and when a petition application is made for
reinstatement of a surrendered license, the Real Estate Commissioner will consider as one of the
criteria of rehabilitation, whether or not restitution has been made to any person who has suffered
monetary losses through "substantially related" acts or omissions of Respondents, whether or not
such persons are named in the Accusations filed in Bureau Case Nos. H-5921 SAC and H-6106
SAC.
