2	3. Based on the findings of fact contained in paragraphs 1 and 2, above, MA,	
3	among other things, solicited and/or performed services for landlords, borrowers, including but	
4	not limited collecting rents and depositing the same into trust accounts, offering places to rent on	
5	behalf of landlords, for or in expectation of a compensation and claimed, demanded, charged,	
6	received, collected or contracted for a fee for such services. Thus, MA violated Sections 10130	
7	and 10131(b) of the Code.	
8	DESIST AND REFRAIN ORDER	
9	Now, therefore SZE YU DANNY MA IS HEREBY ORDERED to immediately	
10	desist and refrain from performing any and all acts within the State of California for which a real	
11	estate license is required, unless and until she obtains a real estate salesperson or broker license,	
12	as appropriate.
