

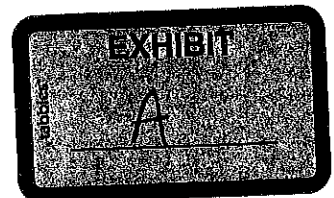

DECLARATION

My name is GERALD K. LAMBERT and I am currently licensed as a real estate broker and/or have license rights with respect to said license.

In lieu of proceeding in this matter in accordance with the provisions of the Administrative Procedure Act (sections 11400 et seq., of the Government Code), I wish to voluntarily surrender my real estate license(s) issued by the California Bureau of Real Estate ("the Bureau"), pursuant to Business and Professions Code section 10100.2.

I understand that by voluntarily surrendering my license(s), I may be re-licensed as a salesperson or as a broker only by petitioning for reinstatement pursuant to section 11522 of the Government Code. I also understand that by voluntarily surrendering my license(s), I agree to the following:



1                   1. The filing of this Declaration shall be deemed as my petition for voluntary  
2 surrender.

3                   2. It shall also be deemed to be an understanding and agreement by me that I  
4 waive all rights I have to require the Commissioner to prove the allegations contained in the  
5 Accusation filed in this matter at a hearing held in accordance with the provisions of the  
6 Administrative Procedure Act (Government Code sections 11400 et seq.), and that I also waive  
7 other rights afforded to me in connection with the hearing such as the right to discovery, the  
8 right to present evidence in defense of the allegations in the Accusation, and the right to cross-  
9 examine witnesses.

10                  3. I further agree that upon acceptance by the Commissioner, as evidenced by  
11 an appropriate order, all affidavits and all relevant evidence obtained by the Bureau in this  
12 matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation  
13 filed in the Bureau Case No. H-6476 SAC may be considered by the Bureau to be true and  
14 correct for the purpose of deciding whether to grant re-licensure or reinstatement pursuant to  
15 Government Code section 11522.

16                  4. I further understand and agree that upon acceptance by the Commissioner, as  
17 evidenced by an appropriate order, of my petition to voluntarily surrender all of my licenses  
18 and license rights under the Real Estate Law, the Bureau will take no further disciplinary action  
19 related to the Accusation filed in Bureau Case No. H-6476 SAC, with the exception of the use  
20 of such affidavits, evidence, and allegations as outlined above in Paragraph 3.

21                  5. I further understand and agree that prior to and as a condition of any petition  
22 for reinstatement made pursuant to Government Code section 11522 being granted, I agree to  
23 be responsible for paying the Commissioner's reasonable cost of the investigation and  
24 enforcement which led to this disciplinary action in Bureau Case No. H-6476 SAC. The  
25 amount of said costs are \$5,088.04.

26                  6. I freely and voluntarily surrender all my licenses and license rights under the  
27 Real Estate Law.
