1	Whenever acts referred to below are attributed to READER or SGR those acts are alleged
2	to have been done by READER or SGR acting by themselves, or by and/or through one or more
3	known or unknown agents, associates, and/or co-conspirators, and using other names or fictitious
4	business unknown at this time.
5	FINDINGS OF FACT
6	1. At no time mentioned, was READER or SGR licensed by the Department
7	in any capacity.
8	2. On the date set forth below, READER and SGR solicited prospective
9	sellers and/or purchasers of real property and business opportunities in expectation of
10	compensation.
11	3. On November 8, 2018, thirty-one chiropractic offices, seven acupuncture
12	practices, three naturopathic practices, two medical practices, and two oriental medicine practices
13	located in California were being solicited for sale by Reader and SGR at the website
14	samreader.com. Reader and SGR advertised that they would "match or beat any broker's full
15	commission" for the sale of a practice.
16	CONCLUSIONS OF LAW
17	4. Based on the findings of fact contained in paragraphs 1 through 3, above,
18	READER and SGR solicited prospective sellers and/or purchasers of business opportunities, for
19	or in expectation of compensation in violation of Sections 10130 and 10131(a) of the Code.
20	DESIST AND REFRAIN ORDER
21	SAMUEL G. READER and S.G.R. INC., whether doing business under your own
22	name, or any other names or fictitious names, ARE HEREBY ORDERED TO IMMEDIATELY
23	DESIST AND REFRAIN from performing any and all acts within the State of California for
