H-7294 SAC MARLENE SOMERVILLE 12 ORDER TO DESIST AND REFRAIN 13 (B&P Code Section 10086) 14 The Real Estate Commissioner (Commissioner) of the State of California has 15 caused an investigation to be made of the activities of MARLENE SOMERVILLE 16 (SOMERVILLE), including engaging in the business of, acting in the capacity of, advertising, or 17 assuming to act as a real estate broker in the State of California within the meaning of Section 18 10131(b) of the California Business & Professions Code (the Code). Based upon the findings of 19 that investigation, as set forth below, the Commissioner has determined and is of the opinion 20 that: 21 SOMERVILLE has violated Section 10130 of the Code by engaging in the 22 business of or acting as a real estate salesperson or broker, within the meaning of Sections 10130 23 (act as a real estate broker or salesman without a license) and 10131(b) (engaging in property 24 management activities) without first having obtained a real estate license from the California 25

Department of Real Estate (Department).

#### FINDINGS OF FACT

- 1. At no time within the last three years was SOMERVILLE licensed by the Department as a real estate salesperson or real estate broker.
- 2. On or about April 24, 2023, complainant Myrtle T., the owner of 1680 Spring Court, executed a Durable Financial Power of Attorney (DFPOA), designating SOMERVILLE as Attorney in Fact. On May 30, 2023, Myrtle T. revoked the DFPOA.
- 3. At all times mentioned herein, continuing up to at least October 1, 2023, SOMERVILLE engaged in the business of, acted in the capacity of, or assumed to act as a real estate broker within the State of California within the meaning of Section 10131(b) of the Code, including leasing, renting, or offering places to rent, negotiating the sale or purchase of leases of real property or collecting rents on real property for compensation or in expectation of compensation, including but not limited to that certain real property commonly known as 1680 Spring Court, Tracy, California.

#### **CONCLUSIONS OF LAW**

3. Based on the findings of fact contained in paragraphs 1 through 3, above, SOMERVILE, among other things, solicited and/or performed services for landlords, borrowers, including but not limited collecting rents and depositing the same into trust accounts, offering places to rent on behalf of landlords, for or in expectation of a compensation and claimed, demanded, charged, received, collected or contracted for a fee for such services. Thus, MA violated Sections 10130 and 10131(b) of the Code.

#### DESIST AND REFRAIN ORDER

Now, therefore MARLENE SOMERVILLE IS HEREBY ORDERED to immediately desist and refrain from performing any and all acts within the State of California for which a real estate license is required, unless and until she obtains a real estate salesperson or
