17 ORDER VACATING DISMISSAL ORDER

18 On November 16, 2023, an Accusation was filed against the real estate broker
19 licenses of Respondents KLEE FINANCIAL GROUP, INC. and KATY L. LEE.

20 On November 7, 2025, separate Stipulation and Agreements were entered into by
21 Respondents and the Commissioner, and Decisions thereby rendered. The Decision disciplined
22 KLEE FINANCIAL GROUP, INC, but stipulated that KATY L. LEE would resolve by way of
23 Citation and Fine. Furthermore, upon satisfaction of conditions, including payment of the
24 administrative fine imposed, a Dismissal Order would be issued to remove/redact all public
25 references to the Accusation only as to Respondent KATY L. LEE.

26 On December 19, 2025, Citation and Fine Compliance Officer Luke Martin verified
27 Respondent KATY L. LEE made payment of the \$1,000.00 imposed administrative fine.
