6	compensated KAMALA'ALA for performing acts which require a real estate license pursuant to
7	Section 10131(b) of the Code (property management activities).

10	leased or rented, solicited places for rent, solicited prospective tenants, collected rents from
11	tenants and ordered repairs on properties owned by landlords on behalf of PLM, including, but
12	not limited to certain real property known as 3024 Fruitvale Avenue in Oakland, California.
13	NOW, THEREFORE YOU, PACIFIC LEGACY MANAGEMENT, ARE
