16 The Real Estate Commissioner (Commissioner) of the State of California has  
17 caused an investigation to be made of the activities of WILLIAM DOUGLAS JOINER  
18 (JOINER) including engaging in the business of, acting in the capacity of, advertising, or  
19 assuming to act as a real estate broker in the State of California within the meaning of Section  
20 10131(a) of the California Business and Professions Code (the Code). Based upon the findings  
21 of that investigation, as set forth below, the Commissioner has determined and is of the opinion  
22 that JOINER has violated Section 10130 of the Code by engaging in the business of or acting as a  
23 real estate salesperson or broker within the meaning of Code Sections 10130 (act as a real estate  
24 broker or salesman without a license) and 10131(a) (engaging in resale of real property) without  
25 first having obtained a real estate license from the California Department of Real Estate  
26 (Department).

1 FINDINGS OF FACT

2 1. At no time mentioned herein, was JOINER licensed by the Department as  
3 either a real estate broker or a real estate salesperson.

4 2. At all times mentioned herein between on or about June 14, 2010 and  
5 continuing up to at least July 15, 2011, JOINER engaged in the business of, acted in the  
6 capacity of, or assumed to act as a real estate broker within the State of California within the  
7 meaning of Section 10131(a) of the Code, including selling or offering to sell, buying or  
8 offering to buy, soliciting prospective sellers or purchasers of, soliciting or obtaining listings  
9 of, or negotiating the purchase, sale or exchange of real property or business opportunity, for  
10 compensation or in expectation of compensation, including but not limited to real property  
11 commonly known as: AP No. 013116102800, Oakland, California and 555-48<sup>th</sup> Street,  
12 Oakland, California.

13 CONCLUSIONS OF LAW

14  
15 3. Based on the Findings of Fact contained in Paragraphs 1 and 2, JOINER,  
16 among other things, solicited and/or performed services for prospective sellers or purchasers  
17 by soliciting or obtaining listings of, or negotiating the purchase, sale or exchange of real  
18 property or business opportunities, for or in expectation of a compensation and claimed,  
19 demanded, charged, received, collected or contracted for an advanced fee for such services.

20 Thus, JOINER violated Sections 10130 and 10131(a) of the Code.

1 DESIST AND REFRAIN ORDER

2 Now, therefore, WILLIAM DOUGLAS JOINER IS HEREBY ORDERED to  
3 immediately desist and refrain from:

- 4 (1) Performing any and all acts within the State of California for which a real estate  
5 salesperson or broker license is required, unless and until he or she obtains a real  
6 estate salesperson or broker license.

16 -NOTICE-

17 Business and Professions Code Section 10139 provides that "Any person acting  
18 as a real estate broker or real estate salesperson without a license or who advertises using words  
19 indicating that he or she is a real estate broker without being so licensed shall be guilty of a  
20 public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by  
21 imprisonment in the county jail for a term not to exceed six months, or by both fine and  
22 imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars  
23 (\$60,000)...."
