21 Pursuant to Section 10087(b) of the California Business and Professions Code
22 (“Code”), HUDSON ALVES REZENDE (“Respondent”) was notified on December 29, 2012
23 of the intention of the California Real Estate Commissioner (“Commissioner”) to issue a Bar
24 Order pursuant to Section 10087(a) of the Code. Respondent failed to request a hearing in
25 writing within fifteen (15) days of service of the *Preliminary Bar Order and Notice of Intention*
26 *to Issue Bar Order.*

27 Pursuant to the authority granted by Section 10087 of the Code, and after review
and consideration of the following facts, the Commissioner makes the following:

1 FINDINGS OF FACT

2 1. On or about June 6, 2011, in the United States District Court for the
3 Northern District of California, Case No. CR-10-00692-001 CRB, Respondent was convicted of
4 violating Title 18, Section 1349 of the United States Code (conspiracy to commit mail and wire
5 fraud), a felony.

6 2. The felony conviction enumerated above bears a substantial relationship
7 under Section 2910, Title 10, California Code of Regulations to the qualifications, functions, or
8 duties of a real estate licensee.

9
10 CONCLUSIONS OF LAW

11 Based on the findings set forth above in paragraphs 1 and 2, the Commissioner
12 determines that you have been convicted of an offense reasonably related to the qualifications,
13 functions, or duties of a person engaged in the real estate business in accordance with the
14 provisions of the Real Estate Law.

15
16 ORDER

17 NOW, THEREFORE, IT IS ORDERED, pursuant to the authority of Section
18 10087 of the Code, that HUDSON ALVES REZENDE is hereby barred and prohibited for a
19 period of thirty-six (36) months from the effective date of this Bar Order, from engaging in any
20 of the following activities in the State of California:


- 21 (A) Holding any position of employment, management, or control in a real
22 estate business;
- 23 (B) Participating in any business activity of a real estate salesperson or a real
24 estate broker;
- 25 (C) Engaging in any real estate related business activity on the premises where
26 a real estate salesperson or real estate broker is conducting business; and,

1 (D) Participating in any real estate related business activity of a finance lender,
2 residential mortgage lender, bank, credit union, escrow company, title
3 company, or underwritten title company.

5 THIS BAR ORDER IS EFFECTIVE IMMEDIATELY.

15 NOTICE

16 Pursuant to Section 10185 of the Business and Professions Code: Any person, including
17 officers, directors, agents or employees of corporations, who willfully violates or knowingly
18 participates in the violation of this (Bar Order) shall be guilty of a misdemeanor punishable by a
19 fine not exceeding ten thousand dollars (\$10,000), or by imprisonment in the county jail not
20 exceeding six months, or by a fine and imprisonment.
