

15 ORDER SUSPENDING REAL ESTATE LICENSE

16 (Section 10186.1 of the California Business and Professions Code)

17 TO: GEORGE FRANCIS ADAIR (hereinafter "Respondent"):

18 On February 4, 2013, the California Department of Real Estate ("Department")
19 received a certified copy of the record of your conviction of a felony, and has confirmed that you
20 are incarcerated after and as a result of your felony conviction.

21 NOW, THEREFORE, IT IS ORDERED under the authority of Section 10186.1 of
22 the California Business and Professions Code ("Code") that the real estate license heretofore
23 issued to Respondent, and the exercise of any privileges, is hereby suspended automatically until
24 such time as Respondent provides proof satisfactory to the Commissioner that Respondent is no
25 longer incarcerated, or pending final determination made after hearing (see "Hearing Rights" set
26 forth below).

1 IT IS FURTHER ORDERED that all license certificates and identification
2 cards issued by the Department which are in the possession of Respondent be immediately
3 surrendered by personal delivery or by mailing via the enclosed, self-addressed envelope to:

8 HEARING RIGHTS: Pursuant to the provisions of Section 10186.1(d) of the
9 Code, you have the right to a hearing to contest the automatic suspension imposed by the
10 Commissioner. If you desire a hearing, you must submit a written request. The request may
11 be in any form, as long as it is in writing and indicates that you want a hearing. Unless a
12 written request for a hearing, signed by or on behalf of you, is delivered or mailed to the
13 Department at:


