26	County of Santa Clara, Case No. B1155794, Respondent was convicted of violating Section
27	273.5(a) the California Penal Code (Inflicting Corporal Injury on a Spouse or Cohabitant), a

1	felony which bears a substantial relationship under Section 2910, Title 10, of the California Code
2	of Regulations (Regulations) to the qualifications, functions or duties of a real estate licensee.

4	The facts alleged above constitute grounds under Sections 490 and 10177(b) of
5	the Code for suspension or revocation of all licenses and license rights of Respondent under Part
6	1 of Division 4 of the Code.

9	Section 10106 of the Code provides, in pertinent part, that in any order issued in
10	resolution of a disciplinary proceeding before the Bureau, the Commissioner may request the
11	Administrative Law Judge to direct a licensee found to have committed a violation of this part to
12	pay a sum not to exceed the reasonable costs of the investigation and enforcement of the case.
13	WHEREFORE, Complainant prays that a hearing be conducted on the allegations
14	of this Accusation and that upon proof thereof, a decision be rendered imposing disciplinary
15	action against all licenses and license rights of Respondent under the Code, for the cost of

17	be proper under the provisions of law.
