I further agree that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence obtained by the Bureau in this matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed in the Bureau Case No. H-12101 SF may be considered by the Bureau to be true and correct for the purpose of deciding whether to grant re-licensure or reinstatement pursuant to Government Code section 11522.
- 4. I further understand and agree that upon acceptance by the Commissioner, as evidenced by an appropriate order, of my petition to voluntarily surrender all of my licenses and license rights under the Real Estate Law, the Bureau will take no further disciplinary action related to the Accusation filed in Bureau Case No. H-12101 SF, with the exception of the use of such affidavits, evidence, and allegations as outlined above in Paragraph 3.
