15	It is hereby stipulated by and between JULIAN VICTOR SOLANO		
16	("Respondent"), represented by Kelsey L. O'Rourke, and the Complainant, acting by and through		
17	Kyle Jones, Counsel for the Department of Real Estate ("Department"), as follows for the		
18	purpose of settling and disposing of the Accusation filed on October 7, 2021, in this matter:		
19	1. All issues which were to be contested and all evidence which was to be		
20	presented by Complainant and Respondent at a formal hearing on the Accusation, which hearing		
21	was to be held in accordance with the provisions of the Administrative Procedure Act ("APA"),		
22	shall instead and in place thereof be submitted solely on the basis of the provisions of this		
23	Stipulation and Agreement.		
24	2. Respondent has received, read, and understands the Statement to		
25	Respondent, the Discovery Provisions of the APA and the Accusation filed by the Department in		
26	this proceeding.

3. Respondent filed a Notice of Defense pursuant to Section 11505 of the 1 2 Government Code for the purpose of requesting a hearing on the allegations in the Accusation. 3 Respondent hereby freely and voluntarily withdraws said Notice of Defense. Respondent 4 acknowledges that Respondent will waive Respondent's right to require the Real Estate 5 Commissioner ("Commissioner") to prove the allegations in the Accusation at a contested hearing held in accordance with the provisions of the APA and that Respondent will waive other 6 7 rights afforded to Respondent in connection with the hearing such as the right to present evidence in defense of the allegations in the Accusation and the right to cross-examine witnesses. 8

9 4. Respondent, pursuant to the limitations set forth below and solely for the
10 purpose of this Stipulation and Agreement, waives any requirement that the Commissioner be
11 required to provide further evidence to prove the factual allegations in the Accusation filed in this
12 proceeding and stipulates that the Commissioner may properly impose discipline as set forth
13 herein as if the evidence in the Commissioner's possession and any allegations based thereon had
14 been proven.

It is understood by the parties that the Commissioner may adopt the
 Stipulation and Agreement as his Decision and Order in this matter thereby imposing the penalty
 and sanctions on Respondent's real estate license and license rights as set forth in the below
 "Order". In the event the Commissioner in his discretion does not adopt the Stipulation and
 Agreement, it shall be void and of no effect, and Respondent shall retain the right to a hearing
 and proceeding on the Accusation under all the provisions of the APA and shall not be bound by
 any admission or waiver made herein.

6. This Decision and Order or any subsequent Order of the Commissioner
 made pursuant to this Stipulation and Agreement shall not constitute an estoppel, merger or bar
 to any further administrative or civil proceedings by the Department with respect to any matters
 which were not specifically alleged in Accusation H-12565 SF.

DETERMINATION OF ISSUES

By reason of the foregoing stipulations, admissions, and waivers and solely for the purpose of settlement of the pending Accusation without hearing, it is stipulated and agreed that the following Determination of Issues shall be made:

The acts and/or omissions of Respondent as described in the Accusation violate
Sections 490 and 10177(b) of the Business and Professions Code ("Code").

<u>ORDER</u>

Respondent JULIAN VICTOR SOLANO's real estate salesperson license is
 revoked; provided, however, a restricted real estate salesperson license shall be issued to
 Respondent pursuant to Section 10156.5 of the Code if Respondent makes application therefor
 for the restricted license within 90 days from the effective date of this Decision and Order. The
 restricted license issued to Respondent shall be subject to all of the provisions of Section 10156.7
 of the Code and to the following limitations, conditions and restrictions imposed under authority
 of Section 10156.6 of that Code:

1. The restricted license issued to Respondent may be suspended prior to
 hearing by Order of the Commissioner in the event of Respondent's conviction or plea of nolo
 contendere to a crime which is substantially related to Respondent's fitness or capacity as a real
 estate licensee.

2. The restricted license issued to Respondent may be suspended prior to
 hearing by Order of the Commissioner on evidence satisfactory to the Commissioner that
 Respondent has violated provisions of the California Real Estate Law, the Subdivided Lands
 Law, Regulations of the Real Estate Commissioner or conditions attaching to the restricted
 license.

3. Respondent shall not be eligible to apply for the issuance of an
 unrestricted real estate license nor for removal of any of the conditions, limitations or restrictions
 of a restricted license until four (4) years have elapsed from the effective date of this Decision
 and Order.

4. Respondent shall submit with any application for license under an
 employing broker, or any application for transfer to a new employing broker, a statement signed
 by the prospective employing real estate broker on a form approved by the Department which
 shall certify:

- (a) That the employing broker has read the Decision and Order of the Commissioner which granted the right to a restricted license; and
 (b) That the employing broker will exercise close supervision over the
 - performance by the restricted licensee relating to activities for which a real estate license is required.

5. Respondent shall notify the Commissioner in writing within 72 hours of
 any arrest by sending a certified letter to the Commissioner at the Department of Real Estate,
 Post Office Box 137000, Sacramento, CA 95813-7000. The letter shall set forth the date of
 Respondent's arrest, the crime for which Respondent was arrested and the name and address of
 the arresting law enforcement agency. Respondent's failure to timely file written notice shall
 constitute an independent violation of the terms of the restricted license and shall be grounds for
 the suspension or revocation of that license.

All licenses and licensing rights of Respondent are indefinitely suspended
 unless or until Respondent pays the sum of \$1,342.30 for the Commissioner's reasonable cost of
 the investigation and enforcement which led to this disciplinary action. Said payment shall be in
 the form of a cashier's check made payable to the Department. The investigative and
 enforcement costs must be delivered to the Department, Flag Section at P.O. Box 137013,
 Sacramento, CA 95813-7013, prior to the effective date of this Order.
