16	The Real Estate Commissioner of the State of California
17	(hereinafter "Commissioner") has caused an investigation to be
18	made of your activities as real estate brokers and, based on the
19	findings of that investigation, as set forth below, is of the
20	opinion that you have violated Sections 2725, 2830, 2831, 2831.1,
21	2831.2, 2832.1 and 2834 of Chapter 6, Title 10, California Code
22	of Regulations (hereinafter the "Regulations") and that you have
23	subjected yourself to possible discipline under Section 10176(e)
24	of the Business and Professions Code (Code).
25	
26	At all times herein mentioned, you, R. C. TEMME
27	CORPORATION (hereinafter RCT), a California corporation, were and

- 1 now are licensed by the Department of Real Estate of the State of
- 2 California (hereinafter "Department") as a corporate real estate
- 3 broker through RICHARD CLAYTON TEMME (hereinafter TEMME) as
- 4 designated officer.
- 5 II
- 6 At all times herein mentioned, you, TEMME, were and
- 7 now are licensed by the Department as a real estate broker,
- 8 individually and as designated officer of RCT.
- 9 III
- 10 All further references herein to "you" include the
- 11 parties identified in Paragraphs I through II, above, and also
- 12 include the officers, directors, employees, agents and real estate
- 13 licensees employed by or associated with said parties and who were
- 14 acting within the course and scope of their authority and employ-
- 15 ment.
- 16 IV
- 17 At all times herein mentioned, you engaged in the
- 18 business of, acted in the capacity of, advertised or assumed to
- 19 act as real estate brokers in the State of California within the
- 20 meaning of Section 10131(d) of the Code, for or in expectation of
- 21 compensation, wherein you solicited borrowers and lenders interested
- 22 in making or acquiring loans secured by liens on real property,
- 23 negotiated said loans, and thereafter serviced said loans.
- 24
- In connection with the aforesaid activities requiring
- 26 a real estate license, from June, 1989, to November 11, 1989, you
- 27 accepted or received funds in trust (hereinafter "trust funds")

- 1 from or on behalf of your various principals and thereafter made
- 2 disbursements of such funds.
- 3 VI
- 4 On March 27, 1990, the Department completed an
- 5 examination of your books and records relating to your activites
- 6 requiring a license which revealed violations of the Regulations
- 7 which occurred during a period of almost six months ending
- 8 November 11, 1989, as set forth in the following paragraphs.
- 9 VII
- As of November 11, 1989, you maintained among other
- 11 accounts, three accounts at Transworld Bank in Woodland Hills.
- 12 One account you used for the sale of trust deeds to private
- 13 investors (#655=017151, hereinafter TA #1). The second account
- 14 was used by you to remit borrower's payments to lenders (#655-
- 15 027688, hereinafter TA #2). In addition, you maintained trust
- 16 funds in an account (#655-817034, hereinafter TA #3) for borrower
- 17 William Spencer.
- 18 VIII
- In connection with the trust funds referred to in
- 20 Paragraph VII, above, you acted in violation of the Regulations in
- 21 that:
- 22 a. TA #3 was not designated as a trust account in
- 23 violation of Section 2830 of the Regulations.
- b. You failed to keep complete and accurate records
- 25 of all trust funds deposited in TA #1, TA #2 and TA #3 and kept
- 26 no records of trust funds not placed in a trust account in violation
- 27 of Section 2831 of the Regulations.

- c. You failed to maintain a separate record for each
- 2 beneficiary who had funds in TA #1 as required by Section 2831.1
- 3 of the Regulations.
- 4 d. You kept no reconciliation of your control records
- 5 for trust funds in TA #1 and TA #2 with the separate records for
- 6 each beneficiary or transaction as required by Section 2831.2 of
- 7 the Regulations.
- 8 e. You disbursed or allowed the disbursements of funds
- 9 from your Disbursement Account without the prior written consent
- 10 of every principal, who then was an owner of funds in said Account,
- 11 where the disbursement of said funds reduced the balance of funds
- 12 in TA #1 and TA #2 to an amount which was, on November 11, 1989,
- 13 \$7077.71 less than the existing aggregate trust fund liability
- 14 to all owners of said funds in said account.
- f. You permitted an unlicensed person covered by no
- 16 fidelity bond to be a signatory on TA #3 in violation of Section
- 17 2834 of the Regulations.
- 18 IX
- You, TEMME, failed to review, initial and date every
- 20 instrument prepared or signed by your real estate licensees, in
- 21 conection with transactions for which a real estate license was
- 22 required, which might have had a material effect upon the rights
- 23 or obligations of a party to the transactions, in violation of
- 24 Section 2725 of the Regulations.
- 25
- And finally, you mixed trust funds received by you and
- 27 deposited in TA #2 with loan payments received by your for loans

1	wholly owned by RCT, thus subjecting yourselves to discipline
2	under Section 10176(e) of the Code.

4	NOW, THEREFORE, YOU ARE ORDERED TO DESIST AND REFRAIN
5	from activities requiring a real estate license unless and until
6	you are in compliance with Sections 2725, 2830, 2831, 2831.1,
7	2831.2, 2832.1 and 2834 of the Regulations.
8	YOU ARE FURTHER ORDERED TO DESIST AND REFRAIN from
9	activities which would subject your licenses and license rights
10	to possible discipline under Section 10176(e) of the Code.
