

ORDER TO DESIST AND REFRAIN

The Real Estate Commissioner of the State of California ("Commissioner") has caused an investigation to be conducted of your activities requiring a real estate license, and based upon the findings of that investigation, is of the opinion that you, AMERICAN FEDERATED MORTGAGE CORP. OF NEVADA (AFMC) and you, PAULETTE MARIE BRISCOE (BRISCOE) have violated Section 10137 of the Business and Professions Code of the State of California ("Code") and Section 2832.1 of Title 10, Chapter 6, California Code of Regulations ("Regulations") and that you, ANTHONY JOSEPH

VELTRE ("VELTRE") and you, DAVID JAMES COOK, aka ASA M. COOK, aka ASA M. COOK, JR ("COOK") and you, RICK ALAN FLOYD ("FLOYD") have violated Section 10130 of the Code.

At all times mentioned herein, you, AFMC, a corporation, were and still are licensed by the Department of Real Estate of the State of California ("Department") as a corporate real estate broker.

II

At all times mentioned herein, you, BRISCOE, were and still are licensed by the Department as a real estate broker in your individual capacity. From December 4, 1991, you were licensed by the Department as the designated officer of AFMC. the designated officer of AFMC, you, BRISCOE, were responsible for the supervision and control of the activities conducted on behalf of AFMC by its officers and employees as necessary to secure full compliance with the Real Estate Law as set forth in Section 10159.2 of the Code.

III

At all times mentioned herein, in Orange County, California, for or in expectation of compensation, you, AFMC, and you, BRISCOE, engaged in the business of, acted in the capacity of, advertised or assumed to act as real estate brokers in the State of California, within the meaning of Sections 10131(d) of the Code, including the operation of a mortgage loan brokerage business with the public wherein lenders and borrowers were solicited for loans secured directly or collaterally by liens on

real property, wherein such loans were arranged, negotiated, processed, and consummated on behalf of others for compensation or in expectation of compensation and for fees often collected in advance.

IV

At all times hereinafter mentioned you, COOK, VELTRE, and you, FLOYD, were not licensed by the Department as a real estate broker or a real estate salesperson employed by a real estate broker. You, COOK, were employed by AFMC as the Senior Vice-President of Operations; you, VELTRE, were employed by AFMC as the Vice-President of Finance, and you, FLOYD, were employed by AFMC as a loan officer.

On February 23, 1993, Department personnel completed an investigative audit of the books and records of you, AFMC and you, BRISCOE, pertaining to your activities as a mortgage loan broker requiring a corporate real estate broker license, for a period commencing on January 1, 1992, and terminating on November 30, 1992, which revealed violations of the Real Estate Law now described.

VI

In connection with the aforesaid mortgage loan broker activities, you, AFMC. and you, BRISCOE, accepted or received funds in trust ("trust funds") from various investors and thereafter deposited said funds into an account at Standard Pacific Savings, Account No. 63005901. In connection with trust funds deposited into this account you violated Section 2832.1 of

funds from the AFMC account without the prior written consent of every principal who was then an owner of trust funds in said account wherein the disbursements reduced the balance of funds in said account on November 30, 1992, to an amount which was at least \$221,387.54 less than the existing aggregate trust fund liability

During a period of time from January 25, 1991, through the end of 1992, you, COOK, for or in expectation of compensation, solicited for and thereafter negotiated the following loans which were to be secured by liens on real property between Frank and Julia Araiza, as the lenders, and the following borrowers and loan

The acts of you, COOK, you, VELTRE and you, FLOYD, are those of a real estate broker as described in Section 10131(d) of the Code.By conducting said acts without a real estate license each of you is in violation of Section 10130 of the Code. By employing said persons to conduct activities requiring a real estate license you, AFMC, and you, BRISCOE, are in violation of Section 10137 of the Code.

NOW, THEREFORE, YOU, AFMC, AND YOU, BRISCOE, AND YOUR OFFICERS, AGENTS, EMPLOYEES, SUCCESSORS AND ASSIGNS ARE ORDERED TO DESIST AND REFRAIN from any and all conduct requiring a real estate license unless and until your conduct is in compliance with Section 2832.1 of the Regulations.

IN ADDITION, YOU, AFMC, AND YOU, BRISCOE, ARE ORDERED TO DESIST AND REFRAIN from employing and/or compensating persons to conduct activities requiring a real estate license unless and until said persons are licensed as a real estate broker or as a real estate salesperson employed by you.
