### ORDER GRANTING UNRESTRICTED LICENSE

On July 5, 1995, a Decision was rendered herein, effective immediately, denying Respondent's application for a real estate salesperson license, but granting Respondent the right to the issuance of a restricted real estate salesperson license. A restricted real estate salesperson license was issued to Respondent on August 14, 1995. Respondent has operated as a restricted licensee without cause for disciplinary action against Respondent since that time.

On July 21, 2003, Respondent petitioned for the removal of restrictions attaching to his real estate salesperson license.

1 I have considered Respondent's petition and the 2 evidence submitted in support thereof. Respondent has demonstrated to my satisfaction that Respondent meets the requirements of law for the issuance to Respondent of an unrestricted real estate salesperson license and that it would not be against the public interest to issue said license to 7 Respondent. NOW, THEREFORE, IT IS ORDERED that Respondent's petition for removal of restrictions is granted and that a real estate salesperson license be issued to Respondent if Respondent satisfies the following conditions within nine (9) 11 months from the date of this Order: 1. Submittal of a completed application and payment of the fee for a real estate salesperson license. Submittal of evidence of having since the most 2. recent issuance of an original or renewal real estate license, taken and successfully completed the continuing education requirements of Article 2.5 of Chapter 3 of the Real Estate

Law for renewal of a real estate license. This Order shall be effective immediately.

19	I acknowledge that I have received and read the Statement of Issues and the Statement to Respondent

21	application for a real estate salesperson license. I understand that the Real Estate Commissioner may hold a
22	hearing on this Statement of Issues for the purpose of requiring further proof of my honesty and truthfulness
23	and to prove other allegations therein, or that he may in his discretion waive the hearing and grant me a
24	restricted real estate salesperson license based upon this Stipulation and Waiver. I also understand that by
25	filing the Statement of Issues in this matter the Real Estate Commissioner is shifting the burden to me to make
26	a satisfactory showing that I meet all the requirements for issuance of a real estate salesperson license. I further

understand that by entering into this stipulation and waiver I will be stipulating that the Real Estate

Commissioner has found that I have failed to make such a showing, thereby justifying the denial of the issuance to me of an unrestricted real estate salesperson license.

I hereby admit that the allegations of the Statement of Issues filed against me are true and correct and request that the Real Estate Commissioner in his discretion issue a restricted real estate salesperson license to me under the authority of Section 10156.5 of the Business and Professions Code.

I am aware that by signing this Stipulation and Waiver, I am waiving my right to a hearing and the opportunity to present evidence at the hearing to establish my rehabilitation in order to obtain an unrestricted real estate salesperson license if this Stipulation and Waiver is accepted by the Real Estate Commissioner. However, I am not waiving my right to a hearing and to further proceedings to obtain a restricted or unrestricted license if this Stipulation and Waiver is not accepted by the Commissioner.

I further understand that the following conditions, limitations and restrictions will attach to a restricted license issued by the Department of Real Estate pursuant hereto:

- 1. The license shall not confer any property right in the privileges to be exercised including the right of renewal, and the Real Estate Commissioner may by appropriate order suspend the right to exercise any privileges granted under this restricted license in the event of:
  - a. The conviction of respondent (including a plea of nolo contendere) to a crime which bears a substantial relationship to respondent's fitness or capacity as a real estate licensee; or
  - b. The receipt of evidence that respondent has violated provisions of the California Real Estate Law, the Subdivided Lands Law, Regulations of the Real Estate Commissioner or conditions attaching to this restricted license.
- 2. Respondent shall not be eligible to apply for the issuance of an unrestricted real estate license nor the removal of any of the conditions, limitations or restrictions attaching to the restricted license until one year has elapsed from the date of issuance of the restricted license to respondent.
- 3. With the application for license, or with the application for transfer to a new employing broker, respondent shall submit a statement signed by the prospective employing broker on a form approved by the Department of Real Estate wherein the employing broker shall certify as follows:
  - a. That broker has read the Statement of Issues which is the basis for the issuance of the restricted

2	b. That broker will carefully review all transaction documents prepared by the restricted licensee
3	and otherwise exercise close supervision over the licensee's performance of acts for which
4	a license is required.

On or about July 17, 1990, in the Superior Court of California, County of Riverside, Riverside Branch, Respondent SHEA KEITH HUTCHINSON, aka Shea Hutchinson, was convicted on his plea of guilty of one count of violating Section 11378 of the Health and Safety Code (H & S) (Possession of a Controlled Substance for Sale, to wit, Methamphetamine), and one count of violating Section 11351.5 of the H & S Code (Possession for Sale and Purchase for the Purpose of Sale, a Controlled Substance, to wit, Cocaine Base), felonies and/or crimes involving moral turpitude which bear a substantial relationship under Section 2910, Title 10, California Code of Regulations, to the qualifications, functions or duties of a real estate licensee.

The crimes of which Respondent was convicted, as alleged in Paragraph III, above, constitute cause for denial of Respondent's application for a real estate license under Sections 480(a)(1) and 10177(b) of the California Business and Professions Code.
