ORDER GRANTING REMOVAL OF DISCIPLINE INFORMATION FROM RESPONDENT'S
PUBLIC INFORMATION PAGE ON THE DEPARTMENT OF REAL ESTATE'S WEBSITE

On May 12, 1999, in Case No. H-27854 LA, a Decision was rendered disciplining the real estate broker license of Respondent effective June 8, 1999.

On January 16, 2006, in Case No. H-27854 LA, a Decision was rendered denying reinstatement of the real estate broker license of Respondent effective March 13, 2006.

On November 21, 2008, in Case No. H-27854 LA, a Decision was rendered denying reinstatement of the real estate broker license of Respondent effective December 22, 2008.

On October 22, 2018, in Case No. H-27854 LA, a Decision was rendered denying reinstatement of the real estate broker license of Respondent, but granting the right to apply for a restricted real estate broker license effective November 14, 2018. A restricted real estate broker was never issued to Respondent and his license remains revoked to date.

1 On May 28, 2024, Respondent was granted the reinstatement of Respondent's real
2 estate broker license.

3 On January 2, 2024, Respondent petitioned for the removal of discipline information
4 from Respondent's Public Information Page on the Department of Real Estate's Website ("the
5 Website").

6 Pursuant to Business and Professions Code section 10083.2(c) the Real Estate
7 Commissioner may remove items that have been posted on the Website "for no less than 10 years".
8 I have considered Respondent's petition and the evidence submitted in support thereof. Respondent
9 has demonstrated to my satisfaction that Respondent does not present a credible risk to the public
10 and that Respondent meets the requirements of law for the removal of discipline posted on the
11 Website for no less than 10 years and that it would not be against the public interest for removal of
12 said discipline.

13 NOW, THEREFORE, IT IS ORDERED that Respondent's petition for removal
14 of discipline information regarding discipline issued in 1999, 2006 and 2008 on the Website is
15 granted.

16 This Order shall become effective immediately.
