This Order amends the Order filed on August 21, 2012, by correcting the case number. On February 03, 2005, a restricted real estate salesperson license was issued by the Department of Real Estate to Respondent, CHARLES DUFFY RIEBE, on the conditions, limitations, and restrictions set forth in the Real Estate Commissioner's Order of January 11, 2005, in Department Case Nos. H-1998 SA and H-28209 LA. The Decision, which became effective February 3, 2005, provided the right to a restricted real estate salesperson license to Respondent and was subject to the provisions imposed under California Business and Professions Code Section 10156.5 and to enumerated additional conditions,

1 limitations, and restrictions. Among those conditions,  
2 limitations, and restrictions, Respondent was required to submit  
3 proof of ongoing payments as agreed to each Federal and State

6 determination made after the hearing on aforesaid Accusation.


