

The Real Estate Commissioner of the State of California ("Commissioner") has caused an investigation to be conducted of your activities as described herein, and based upon the findings of that investigation, is of the opinion that you have violated Section 10130 of the California Business and Professions Code (Code).

At no time mentioned were you, MARC A. MEDINA, licensed by the Department of Real Estate of the State of California ("Department") as a real estate broker nor were you licensed as a real estate salesperson employed by a real estate broker.

Your conduct, as described in Paragraph II, is that of a real estate broker as set forth in Section 10131(d) of the Code.


IV

You violated Section 10130 of the Code by acting in the capacity of a broker when you were not licensed as a real estate broker nor were you licensed as a real estate salesperson and employed by a real estate broker.

NOW, THEREFORE, YOU, MARC A. MEDINA, ARE ORDERED TO DESIST AND REFRAIN from performing any and all acts requiring a real estate license in California unless and until such time as you obtain the required license from the Department.
