AND REFRAIN

The Real Estate Commissioner of the State of California has caused an investigation to be made of your activities as a real estate broker and, based on the findings of that investigation, is of the opinion that you, VPM MANAGEMENT, INC., and you, PHILIP HAROLD McNAMEE, have violated Sections 10145(a), 10137, and 10176(f) of the Business and Professions Code (hereinafter Code), as well as Regulations 2731 and 2832 (all references herein to Regulations refer to the California Code of Regulations, Title 10, Chapter 6).

That at all times herein mentioned, you, VPM
MANAGEMENT, INC., were licensed by the Department of Real Estate
of the State of California (hereinafter Department) as a

corporate real estate broker and you, PHILIP HAROLD MCNAMEE, were licensed as the designated officer of said corporation.

TT

At all times herein mentioned, you, and each of you, on behalf of others in expectation of compensation, engaged in the business, acted in the capacity of, advertised or assumed to act as a real estate broker in the State of California within the meaning of Section 10131(b) of the Code, including soliciting renters and owners, negotiating rental agreeents, and collecting rents from real property.

III

During 1998 and 1999, in connection with the aforesaid real estate brokerage activities, you, and each of you, accepted or received funds from renters and owners and thereafter made disbursements of such funds.

TV

In connection with your activities as a real estate broker, as described above, you, and each of you, acted in violation of the Real Estate Law as follows:

- Violated Section 10145(a) of the Code and Regulation 2832 by maintaining trust accounts which were not in the broker's name as trustee.
- Violated Regulation 2731 by employing the unlicensed fictitious business name VPM, INC., in your real estate brokerage business.
- Violated Section 10137 of the Code by emploing David G. Walton, an unlicensed individual, to solicit and

negotiate rental agreements. Such activities require a real estate license under Section 10131(b) of the Code.

4. Violated Section 10176(f) of the Code by employing property management agreements which do not contain a specific termination date.

NOW, THEREFORE, YOU, VPM MANAGEMENT, INC., AND YOU, PHILIP HAROLD McNAMEE, ARE ORDERED TO DESIST AND REFRAIN from performing any and all activities for which a real estate broker license is required until you comply with all provisions of the Real Estate Law as discussed in this Order.
