The Complainant, Thomas McCrady, a Deputy Real Estate Commissioner of the State of California, makes this Accusation against Respondent in his official capacity.

ΙI

Respondent made application to the Department of Real Estate of the State of California (hereinafter "Department") for a real estate salesperson license on or about January 23, 2001.

III

On or about September 23, 1996, in the United States District Court, Central District of California, in case number 95-998(A)-HLH, Respondent was convicted upon his plea of guilty to one count of violating 21 USC 846 (conspiracy to possess with intent to distribute) and two counts of violating 21 USC 841(a)(1) (possession with intent to distribute cocaine) felony crimes of moral turpitude that are substantially related to the qualifications, functions or duties of a real estate licensee. Respondent was sentenced to serve eighty-seven (87) months for each count with the terms to run concurrently and to an additional five (5) years of supervised release thereafter.

IV

The crimes for which Respondent was convicted as set forth above in Paragraph III constitute grounds for denial of Respondent's application for a real estate license under Sections 475(a), 480(a) and 10177(b) of the California Business and Professions Code.

This statement of Issues is brought under the provisions of Section 10100, Division 4 of the Business and Profession Code of the State of California and Sections 11500 through 11529 of the Government Code.

WHEREFORE, Complainant prays that the above entitled matter be set for hearing and, upon proof of the charges contained herein, that the Commissioner refuse to authorize the issuance of, and deny the issuance of, a real estate salesperson
