

BATEMAN were the owners or agents of the owner of a time-share subdivision of real property within the meaning of Section 11004.5(e) of the Code.

The subdivision is located in the County of Riverside, State of California, and is known as Adriactic Villa.

You, and each of you, on or about December 7, 1999, offered and sold to Christine Z. Segard a time-share estate in the subdivision.

IV

You, and each of you, violated Section 11010 of the Code by failing to notify the Department in writing of your intention to offer and sell the subdivided land prior to the time it was offered and sold. You violated Section 11018.2 of the Code by offering and selling interests in the subdivision without having first obtained a subdivision public report from the Department.

V

You, LAWRENCE L. SOFONIO and HENDRICKA C. SOFONIO, violated Section 11013.4 of the Code by offering and selling interests in the subdivision without first complying with the requirements of the Code Section.
