#### PROPOSED DECISION

Administrative Law Judge N. Gregory Taylor, State of California, Office of Administrative Hearing, heard this matter in Los Angeles, California on February 11<sup>th</sup>, 2003.

James Peel, Real Estate Counsel, represented Complainant Maria Suarez, a Deputy Real Estate Commissioner Department of Real Estate of the State of California ("Department").

Larry R. Artis, Attorney at Law, represented Respondent Daniel Rene Barillas.

The above entitled matters were heard in a combined hearing pursuant to notice given be the Department.

The matter was submitted on February 11<sup>th</sup>, 2003.

### **FACTUAL FINDINGS**

1. Complainant, Maria Suarez, a Deputy Real Estate Commissioner with the Department, made the Statement of Issues and Accusation in this proceeding in her official capacity.

2. Respondent Daniel Rene Barillas is presently licensed by the Department as a Real Estate Salesperson under the Real Estate Law (Part 1, Division 4 of the Business and Professions Code ("Code"). Respondent's Real Estate License was first issued in September 19, 1990. At all times pertinent to this proceeding Respondent was so licensed. The current license will expire on September 18<sup>th</sup>, 2006.

3. On or about April  $22^{nd}$ , 2002, Respondent applied to the Department for a Real Estate Broker's License. In that application, Respondent disclosed that in January 2002 he had been convicted of a violation of Penal Code Section 273.5 (a) – a misdemeanor.

4. On or about February 20<sup>th</sup>, 2002, in the Superior Court of the State of California for the County of Los Angeles, Respondent entered a plea of nolo contendere to a violation of Penal Code Section 273.5 (a) – spousal abuse – a misdemeanor. The Court placed Respondent on summary probation for a period of three years on certain terms and conditions, including, completing a one year domestic violence counseling program; contributing 25 days of community labor in lieu of jail; not harassing etc. his wife; and payment of certain costs and fines. As of the time of the hearing in this matter, Respondent had three more anger management classes to attend before completing that requirement. He has the performed community labor by working at a park in the City of Ontario. He remains on probation, which will end in 2005.

5. Respondent and his wife, Lissette Barillas, own the business (Empire Lending Corporation) where they both work.

6. On January 11<sup>th</sup>, 2002, Lissette Barillas arrived at work before Respondent. An employee called in sick. Lissette Barillas moved another employee to cover for the absent person. When Respondent arrived at work, he became very upset with the reassignment. An argument ensued between him and his wife. Respondent made some loud comments to her and then grabbed or pulled her by her arm. She fell against a doorway. Subsequently, it was determined that she had black and blue marks on her arm. Respondent left the office. His wife called the police. He was interviewed by the police at a nearby restaurant. This incident was the basis of the criminal proceeding against Respondent.

7. Respondent has been married to his wife for 22 years. They have two daughters, 15 and 13 years of age. There had been problems in their marriage. However, they are living together. Respondent stated that, since he has been taking the anger management course, their relationship had greatly improved.

8. Respondent has no other criminal convictions. There have been no other disciplinary proceedings against him by the Department.

9. It has been less than two years since Respondent's criminal conviction.

10. The crime of which Respondent was convicted is substantially related to the qualifications, functions or duties of a licensee of the Department in that it involved the

doing of an unlawful act with the intent or threat of doing substantial injury to the person of another.

### LEGAL CONCLUSIONS

1 1. Cause exists, pursuant to Business and Professions Code Sections 480 (a) and 1077 (b), to deny Respondent's application for a Real Estate Broker's license in that he has been convicted of a crime substantially related to the qualifications, functions, or duties of a Real Estate licensee as defined in Section 2910 (8) of the Title 10 of the California Code of Regulations and more fully set forth in Paragraphs 4, 6 and 10 of the Factual Findings.

2. Cause similarly exists to take disciplinary action against Respondent's Real Estate Salesperson's license for the same reasons as set forth in Paragraph 1 of Legal Conclusions above.

3. Respondent does not meet the Department's criteria for rehabilitation set forth in Sections 2922 and 2912 of Title 10 of the California Code of Regulations in that it has been less than two years since his conviction as more fully set forth in Paragraphs 4, 6 and 9 of the Factual Findings.

#### <u>ORDER</u>

1. Respondent Daniel Rene Barillas' application for a Real Estate Broker's License is denied.

2. All licenses and licensing rights of Respondent Daniel Rene Barillas under the Real Estate Law are revoked.
