

The Real Estate Commissioner of the State of California (hereinafter "Commissioner") has caused an investigation to be made of your activities as real estate brokers and based upon the findings of that investigation, as set forth below, is of the opinion that you, CAPITAL COMMERCIAL REAL ESTATE SERVICES INC., doing business as NAI Capital Commercial, and you, RICHARD STEVEN GOLD, individually and as designated officer of Capital Commercial Real Estate Services Inc., violated Section 10145 of the California Business and Professions Code (hereinafter "Code")

and Sections 2831 and 2831.2 of Title 10, Chapter 6, California Code of Regulations (hereinafter "Regulations").

At all times material herein, you, CAPITAL COMMERCIAL REAL ESTATE SERVICES INC., were and now are licensed by the Department of Real Estate of the State of California (hereinafter "Department") as a corporate real estate broker through GOLD as the designated officer and broker responsible, pursuant to the provisions of Code Section 10159.2, for supervising the activities requiring a real estate license conducted on behalf of CAPITAL by CAPITAL's officers, agents and employees.

At all times mentioned herein, you, RICHARD STEVEN GOLD ("GOLD"), were and now are licensed by the Department as a real estate broker, individually and as the designated officer of CAPITAL. As the designated broker-officer, you, GOLD, currently are and at all times material herein were responsible for the supervision of the activities of the officers, agents and employees of CAPITAL for which a license is required pursuant to Code Section 10159.2.

On November 3, 1999, in Case No. H-28153 LA, a Decision was rendered against Respondents CAPITAL COMMERCIAL REAL ESTATE SERVICES INC., and RICHARD STEVEN GOLD, individually and as designated officer of Capital Commercial Real Estate Services Inc. for violations of Code Sections 10145 and 10177(d) Regulations 2726 and 2832. Respondents' licenses were suspended for thirty (30) days and stayed upon terms and conditions including a chargeable audit.

At all times herein mentioned, you, CAPITAL, engaged in the business of, acted in the capacity of, advertised or assumed to act as a real estate broker in the State of California, within the meaning of Code Sections 10131(a) and 10131(b) as a commercial resale and leasing broker.

On or about March 25, 2002, the Department completed an examination of CAPITAL's books and records pertaining to the activities described in Paragraph 5, above. The audit examination revealed violations of the Code and the Regulations as set forth below, and more fully discussed in Audit Report LA 010153 [Commercial Resale] and exhibits and workpapers attached to said audit report.

The audit examination determined that, in connection with the commercial resale and leasing activities described in Paragraph 5, above, you, CAPITAL, accepted or received funds, including funds in trust ("trust funds") from or on behalf of actual or prospective parties to transactions handled by you and thereafter made deposit or disbursement of such funds. During the audit period you, CAPITAL, maintained one (1) trust account at the US Bank located at 16030 Ventura Blvd, Encino, CA 91436,

- (b) Failed to perform a monthly reconciliation of aggregate balance of all separate beneficiary or transaction records maintained pursuant to Regulation 2831.1 with the control record of all trust funds received and disbursed required by Regulation 2831 for the trust account, Code Section 10145 and Regulation 2831.2
