ORDER TO DESIST AND REFRAIN

No. H-31067 LA

The Real Estate Commissioner of the State of California has caused an investigation to be made of your activities as a real estate broker, and based on the findings of that investigation is of the opinion that ZERNOX FINANCIAL SERVICES, INC., and EVELYN ARNOLD have violated Section 10145(a) of the Business and Professions Code (hereinafter Code) as well as Regulation 2725, 2752, 2831, 2831.1, 2831.2 (all references herein to Regulations refer to the California Code of Regulations, Title 10, Chapter 6), and Section 17006 of the Financial Code.

That at all times herein mentioned, you, ZERNOX FINANCIAL SERVICES, INC., were licensed by the Department of Real Estate of the State of California (hereinafter Department) as a corporate real estate broker and you, EVELYN ARNOLD, were licensed as the designated officer of said corporation.

At all times herein mentioned, you, ZERNOX FINANCIAL SERVICES, INC., and EVELYN ARNOLD, on behalf of others in expectation of compensation engaged in the business, acted in the capacity of, advertised or assumed to act as a real estate broker in the State of California within the meaning of Section 10131(a) and (b) of the Code, including soliciting buyers and sellers and negotiating the sale of real property and collecting rents from real property. In addition, Respondents operated pursuant to the exemption set forth in Financial Code Section 17006(a)(4).

III

During 2002 and 2003, in connection with the aforesaid brokerage activities, you, ZERNOX FINANCIAL SERVICES, INC., and EVELYN ARNOLD, accepted or received funds from buyers and sellers and renters and thereafter made disbursements of such funds. You maintained Trust Account Nos. 1891396655 and 1891087791, Co-America, 9920 S. La Cienega Blvd. 11th Floor, Inglewood, Cal.

IV

In connection with your activities as a real estate broker, as described above, you, ZERNOX FINANCIAL SERVICES, INC. and EVELYN ARNOLD, acted in violation of the Real Estate Law as follows:

(1) Violated Regulation 2831 in that the columnar record was not complete and accurate. The control records

consisted of separate check and receipt reports, but did not provide a daily balance of all trust funds received and disbursed. The total of trust funds received and disbursed when merged did not reflect the proper balance of the trust funds being held.

- (2) Violated Regulation 2831.1 in that the separate records were not complete and accurate. The records did not provide a daily balance of all trust funds received and disbursed.
- (3) Violated Regulation 2831.2 by failing to maintain monthly reconciliation for the trust account between the control records and the separate records.
- (4) Violated Regulation 2725 by failing to establish policies for reviewing the handling of trust funds in connection with escrow and property management activities.
- (5) Violated Regulation 2752 by failing to notify the Department upon the employment of salespersons.
- (6) Violated Section 17600 of the Financial Code by acting in the capacity of an escrow holder in the Pace transaction in which you did not perform acts for which a real estate license is required.

NOW, THEREFORE, YOU, ZERNOX FINANCIAL SERVICES, INC., AND EVELYN ARNOLD, ARE ORDERED TO DESIST AND REFRAIN from performing any and all activities for which a real estate broker license is required until you comply with all provisions of the Real Estate Law as discussed in this Order.
