DECLARATION

Regulations) which could result in the filing of an Accusation to revoke or suspend its real estate license; and pursuant to Business and Professions Code Section 10100.2, HUS MORTGAGE CORPORATION wishes to voluntarily surrender its real estate broker license issued by the Department.

I understand that HUS MORTGAGE CORPORATION by so voluntarily surrendering its license, can only have it reinstated in accordance with the provisions of Section 11522 of the Government Code and this Declaration.

I agree on behalf of HUS MORTGAGE CORPORATION that the filling of this Declaration shall be deemed to be its petition to voluntarily surrender its real estate license and shall also be deemed to be an understanding and agreement by it that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all other relevant statements, declarations and evidence obtained during the course of the investigation prior to the Commissioner's acceptance may be considered by the Department to be true and correct for the purpose of deciding whether or not to grant reinstatement of its license pursuant to the provisions of Government Code Section 11522. This understanding and agreement is made without admitting or denying the truth or contents of the aforementioned documents.

I declare under penalty of perjury under the laws of the State of California that the above is true and correct and that I am acting freely and voluntarily on behalf of HUS MORTGAGE
