

The Real Estate Commissioner of the State of California (Commissioner) has caused an investigation to be conducted of your activities, as described herein, and based upon the findings of that investigation, is of the opinion that you, MARGARET ANN DAILEY aka Margaret Miller ("DAILEY"), operating under the fictitious business name of Mortgage Capital Resources, have violated Section 10130 of the California Business and Professions

At no time herein mentioned, were you licensed by the Department of Real Estate of the State of California (Department) as a real estate broker or a real estate salesperson employed by a real estate broker.

2.

On August 8, 1993, you, DAILEY, were originally licensed as a real estate salesperson. Your license expired on February 7, 1997.

3.

At your office located at 61 Mollison Dr., Simi Valley, California 93065, from on or about August 1, 2001, to date, you, DAILEY, have held yourself out as and represented that you were a real estate salesperson doing business under the fictitious business name of Mortgage Capital Resources.

4.

On or about September 3, 2003, you, DAILEY, dba

Mortgage Capital Resources originated and performed services for,
or attempted to refinance the property located at 6309 Agnes Ave,
North Hollywood for borrower Layna McAllister, in violation of
Code Section 10130.

5.

On October 8, 2003, the Department completed an audit examination of the books and records of An dba MGA Realty & Mortgage Co., Mortgage Capital Resources and Valley Wide Mortgage

Services, pertaining to the mortgage and loan brokerage activities described in Paragraph 4 that require a real estate The audit examination covered a period of time beginning on August 1, 2001 to July 31, 2003. The audit examination; -Audit-Report LA 020466 and the exhibits and workpapers attached to said audit report, revealed that during a period of April 25, 2003 and July 31, 2003, you, DAILEY, dba Mortgage Capital Resources originated, negotiated, and were compensated by George M. An, real estate broker, for mortgage loans made to borrowers Brower, Skillen, Sanders, Chavez, Novak, Carson, Neiditz, in violation of Code Section 10130.

Your acts, DAILEY, as described in Paragraph 3, above, are acts requiring a real estate license under the provision of Code Section 10131(a).

7.

You, DAILEY, violated Code Section 10130 by acting in the capacity of a licensee when you were not licensed as a real estate broker or as a real estate salesperson employed by a real estate broker.

8.

The acts performed by you DAILEY, as described in Paragraph 4, above, are acts requiring a real estate license under the provision of Code Section 10131(d).

You, DAILEY, by acting in the capacity of a real estate licensee, described in Paragraph 4, above, when you were not licensed as a real estate licensee, have violated Code Section 10130.

NOW, THEREFORE, YOU, MARGARET ANN DAILEY aka Margaret Miller, ARE ORDERED TO DESIST AND REFRAIN from performing any and all acts requiring a real estate license in California, individually and under any fictitious business name, unless and until you obtain the required license from the Department.
