ORDER TO DESIST

AND REFRAIN

The Real Estate Commissioner of the State of California (Commissioner) has caused an investigation to be conducted of your activities, as described herein, and based upon the findings of that investigation, is of the opinion that you, REX RICHARD PITTS, have violated Section 10130 of the California Business and Professions Code (Code).

On August 5, 1993, you, REX RICHARD PITTS ("PITTS"), were originally licensed as a real estate broker. Your real estate broker license expired on August 4, 2001, without renewal.

On December 24, 2003, the Department completed an audit examination of the books and records of CLEMENT G. SMITH dba

Buyers Real Estate and Buyers Mortgage pertaining to the residential resale, property management, and mortgage loan activities that require a real estate license. The audit examination covered a period of time beginning on January 1, 2003

3.

During the abovesaid audit period, you had held yourself out as and represented that you were a real estate broker, employed as a broker-associate for Clement G. Smith dba Buyers Mortgage.

Specifically, while employed by Clement G. Smith dba
Buyers Mortgage, you solicited borrowers Paolo and Lisa Cuomo to
for a home purchase loan for the property located at 15045
Nordoff #118, North Hills, Ca 91343, including a face-to-face
interview with the Cuomo's and including signing the Residential
Loan Application as interviewer on February 7, 2003, for and
expectation of compensation.

5.

In addition to the Cuomo loan transaction, you, REX RICHARD PITTS, negotiated several other home purchase and refinance loans during the aforesaid audit period including the

Cafferty, Mutyada, Johnson and Campos loans, for which you received compensation from Clement G. Smith dba Buyers Mortgage in total amount of \$80,461.98.

6.

Your acts, PITTS, as described in Paragraph 3 through 5, above, are acts requiring a real estate license under the provision of Code Section 10131(a) and 10131(d).

7.

You, PITTS, violated Code Section 10130 by acting in the capacity of a licensee when you were not licensed as a real estate broker or as a real estate salesperson employed by a real estate broker.

NOW, THEREFORE, YOU, REX RICHARDS PITTS, ARE ORDERED TO DESIST AND REFRAIN from performing any and all acts requiring a real estate license in California, individually and under any fictitious business name, unless and until you obtain the required license from the Department.
