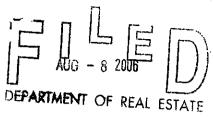

ORDER TO DESIST

AND REFRAIN

The Real Estate Commissioner of the State of California (Commissioner) has caused an investigation to be conducted of your activities, as described herein, and based upon the findings of that investigation, is of the opinion that YOU, GLOBAL MORTGAGE FUNDING INC. dba Inforte Financial ("GMFI") and YOU, HENRY PERPULI SOLIS ("SOLIS"), individually and as designated officer of Global Mortgage Funding Inc., have violated Section 17006(a)(4) of the California Financial Code (Code).

At all times material herein, GMFI was licensed by the Department of Real Estate of the State of California (hereinafter "Department") as a corporate real estate broker by and through SOLIS, as the designated officer and broker responsible, pursuant to Code Section 10159.2 of the Business and Professions Code for supervising the activities requiring a real estate license conducted on behalf GMFI of by GMFI's officers, agents and employees, including SOLIS.

2.

At all times mentioned, in the City of Newport Beach, County of Orange, you, GMFI acted as a real estate broker and conducted mortgage loans pursuant to Code Section 10131(d).

Additionally, you, GMFI conducted broker-controlled escrows through your escrow division, U.S. Escrow Express.

3.

On February 25, 2005, the Department completed an audit examination of the books and records of GMFI pertaining to the mortgage loan and broker-escrow activities described in Paragraph 2, above. The audit examination covered a period of time beginning on May 1, 2003 to August 31, 2004. The audit examination revealed violations of the Code and the Regulations as set forth in Paragraph 4, and more fully discussed in Audit Report LA 030470 and LA 040112 and the exhibits and workpapers attached to said audit reports.

You conducted three (3) third party loan escrows for

borrowers David Carlson, Escrow #3114-GM, Gilbert Rouse, Escrow #3143 GM and Charles Thompson Escrow #2884-GM wherein neither you, GMFI or you, SOLIS, were performing acts in the course of or incidental to a real estate transaction, in which you were an agent or party to the transaction and in which you were performing acts for which a real estate license is required.

Your conduct, GMFI and SOLIS, as described in Paragraph 4, is in violation of California Financial Code Section 17006(a)(4).

NOW, THEREFORE, YOU, GLOBAL MORTGAGE FUNDING INC. dba
Inforte Financial and YOU, HENRY PERPULI SOLIS, ARE ORDERED TO
DESIST AND REFRAIN from performing any and all acts requiring a
real estate license in California unless and until you are in
compliance with California Financial Code Section 17006(a)(4).
