5 or assumed to act as a real estate broker in the State of
6 California, within the meaning of Code Section 10131(d) for or
7 in expectation of compensation. Your activities included, but
8 were not necessarily limited to, the operation of or conduct of
9 mortgage lending activities on behalf of Eagle Uno Mortgage
10 Corporation, wherein you solicited borrowers or lenders for, or
11 negotiated loans and/or collected payment, or performed services
12 for borrowers or lenders or note owners in connection with loans
13 secured directly or collaterally by liens on real property or on
14 a business opportunity.

17 acts requiring a real estate broker license under the provisions




