

Frank M. Buda, Attorney for KMC Mortgage Corporation and Segway Financial, Inc., and Mary E. Work, Attorney for Robert William Schultz advised that they would be representing the parties in a hearing held before the Department pursuant to Section 10086 of the Business and Professions Code of the State of California.

YOU ARE HEREBY NOTIFIED that a hearing on the Order to Desist and Refrain will be held before the Department of Real Estate at Office of Administrative Hearings, 320 West Fourth Street, Suite 630, Los Angeles, California, on August 1, 2 and 3, 2007, at the hour of 9:00 a.m., or as soon thereafter as the matter can be heard, upon the matters contained in the Order to Desist and Refrain filed April 30, 2007.

You may be present at the hearing and may be represented by counsel, but you are neither required to be present at the hearing nor are you required to be represented by counsel.

You may present any relevant evidence and will be given full opportunity to cross-examine all witnesses testifying against you. You are entitled to the issuance of subpoenas to compel the attendance of witnesses and the production of books, documents or other things by applying to the Department of Real Estate.



You, KMC MORTGAGE CORPORATION and SEGWAY FINANCIAL, INC., knowingly advertised, printed, displayed, published, distributed, or caused or permitted to be advertised, printed, displayed, published, distributed, statements or representations with regard to the rates, terms, or conditions for making, purchasing, or negotiating loans on real property which were false, misleading, or deceptive.

Your conduct is in violation of Code Sections 10235, 14701 and 14702, and Regulations 2847.3(b) and 2848.
