DECLARATION

I am authorized and empowered to sign this declaration on behalf of NATIONAL HOMEBUYERS ALLIANCE. I am acting on behalf of NATIONAL HOMEBUYERS ALLIANCE in this matter.

In lieu of proceeding in this matter in accordance with the provisions of the Administrative Procedure Act (Sections 11400 et seq., of the Business and Professions Code) NATIONAL HOMEBUYERS ALLIANCE wishes to voluntarily surrender its real estate license issued by the Department of Real Estate

("Department"), pursuant to Business and Professions Code Section 10100.2.

I understand that NATIONAL HOMEBUYERS ALLIANCE, by so voluntarily surrendering its license, can only have it reinstated in accordance with the provisions of Section 11522 of the Government Code. I also understand that by so voluntarily surrendering its license, NATIONAL HOMEBUYERS ALLIANCE agrees to the following:

The filing of this Declaration shall be deemed as its petition for voluntary surrender. It shall also be deemed to be an understanding and agreement by NATIONAL HOMEBUYERS ALLIANCE that, it waives all rights it has to require the Commissioner to prove the allegations contained in the Accusation filed in this matter at a hearing held in accordance with the provisions of the Administrative Procedure Act (Government Code Sections 11400 et seq.), and that it also waives other rights afforded to it in connection with the hearing such as the right to discovery, the right to present evidence in defense of the allegations in the Accusation and the right to cross-examine witnesses. I further agree on behalf of NATIONAL HOMEBUYERS ALLIANCE that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence obtained by the Department in this matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed in the Department Case No. H-34006 LA, may be considered by the Department to be true and correct for the purpose of deciding



IV

On or about April 1, 2005, the Franchise Tax Board of the State of California, forfeited the powers, rights and privileges of Respondent.

V

The conduct of Respondent, NATIONAL HOMEBUYERS

ALLIANCE, as alleged above, was in violation of Section 2742 of

Title 10, Chapter 6, California Code of Regulations, and subjects

its real estate license and license rights to suspension or

revocation pursuant to Sections 10177(d) and (f) of the Code.
