
The licenses and license rights of Respondent PREMIER

7 On or about September 1, 2005, pursuant to the
8 provisions of Section 23302 of the California Revenue and
9 Taxation Code, the rights and privileges of, PREMIER FINANCIAL
10 NETWORK GROUP, INC., were suspended by the California Secretary
11 of State. Said suspension is a violation of Section 10177(f) of
12 the Code in that it would have constituted grounds for the
13 denial of the corporate real estate broker license under Section
14 2742 of the Regulations.

18 cause under Section 10177(f) of the Code for suspension or
19 revocation of the license and license rights of Respondent under
