AND REFRAIN

The Real Estate Commissioner of the State of California (Commissioner) has caused an investigation to be conducted of your activities, as described herein, and based upon the findings of that investigation, is of the opinion that:

YOU, GEORGE GERARD GRACHEN ("GRACHEN"), have violated Section 10130 of the California Business and Professional Code ("Code").

1.

At no time herein mentioned, were YOU, GRACHEN licensed by the Department of Real Estate of the State of California (Department) as a real estate broker or a real estate salesperson employed by a real estate broker. You were formerly licensed as

a real estate salesperson on May 9, 1997. On May 8, 2001, in case number H-27900 LA, your real estate salesperson license was revoked for violations of Code Section 10130.

2.

At all times mentioned, in the City of Cypress, County of Orange, you, GRACHEN, President of R&G Lending Inc., acted as a real estate broker and as an unlicensed loan officer where you conducted mortgage loan activities pursuant to Code Section 10131(d) requiring a real estate license including soliciting borrowers or lenders and for negotiating loans and performing services for borrowers.

On December 6, 2005, the Department completed a followup audit examination of the original audit (LA 030100) of the
books and records of R&G Lending Inc., pertaining to its mortgage
and loan activities that require a real estate license. The
audit examination covered a period of time beginning on June 17,
2005 to October 24, 2005. The audit examination revealed
violations of the Code as set forth in the following paragraphs,
and more fully discussed in the follow-up audit (LA 050121) and
the exhibits and workpapers attached to said audit report,
including your unlicensed loan agent activity.

In the course of activities described in Paragraph 2 above, and during the examination period described in Paragraph
