At all times mentioned herein, you, HOME BASE FUNDING INC., were licensed by the Department of Real Estate of the State of California (hereinafter "Department") as a corporate real estate broker with Respondent GIL VILLOCINO PACIFICAR as the designated officer.

At all times mentioned herein, you, GIL VILLOCINO PACIFICAR, individually, and as designated officer for Home Base Funding Inc., and doing business as Prime Properties Realty and Velirs World Loans, were licensed by the Department as a real estate broker.

You, HOME BASE FUNDING INC. and GIL VILLOCINO

PACIFICAR, knowingly advertised, printed, displayed, published,
distributed, or caused or permitted to be advertised, printed,
displayed, published, distributed, statements or representations
with regard to the rates, terms, or conditions for making,
purchasing, or negotiating loans on real property which were
false, misleading, or deceptive.

Your conduct, as alleged in Paragraph 3, above, is in violation of Code Sections 10235 and Section 2848, subdivisions (2), (5) and (16), of the Regulations.

You, HOME BASE FUNDING INC. and GIL VILLOCINO PACIFICAR, placed one or more advertisements disseminated

primarily in the State of California for the making or arranging of a loan, including a solicitation for borrowers or potential investors, that failed to disclose within the printed text of the advertisement, or the oral text in the case of a radio or television advertisement, your real estate broker license number. Your conduct, as alleged in Paragraph 5, above, is in violation of Code Sections 10235.5 and 10236.4. You, HOME BASE FUNDING INC. and GIL VILLOCINO PACIFICAR, used a fictitious business name for activities requiring the issuance of a real estate license without filing an application for the use of such name with the Department as required by the provisions of Code Section 10159.5. /// 

NOW, THEREFORE, YOU, HOME BASE FUNDING INC. and GIL 1 VILLOCINO PACIFICAR, ARE ORDERED TO DESIST AND REFRAIN from performing any and all activities for which a real estate broker 3 license is required until you comply with all provisions of the 5 Real Estate Law as discussed in this Order.
