	4	the Subdivided Lands Law, Regulations of the Real Estate Commissioner or conditions
	5	attaching to her restricted license.
	6	On April 26, 2013, in Case No. H-38839 LA, an Accusation was filed against
	7 8	Nancy Veronica Cea, based on and pertaining to an audit of Respondent's real estate sales and
	9	broker-controlled escrow brokerage which alleged that Respondent failed to comply with the

	11	10145, 10148, and 10159.5 and Regulations 2731, 2831, 2831.1, 2831.2, 2832(a), 2834,
